

**REVISED****ELECTION COMMISSION OF PAKISTAN**

**PUBLIC NOTICE**

WHEREAS, in pursuance of the provisions of Section 57 of the Elections Act, 2017 (No. XXXIII of 2017), the Election Commission of Pakistan vide its Notification No. F.2 (5)2018-Cord dated **31<sup>st</sup> May, 2018** has called upon the voters of National Assembly to elect their representatives from each of these constituencies to the general seats and in connection therewith appointed dates for various activities of election. Para 2 of the said Notification provided that the said election Programme shall also apply to election to the seats reserved for non-Muslims in the National Assembly.

Whereas, in pursuance of provision of section 51 of the Election Act, 2017 (Act No. XXXIII of 2017) I, **Ghulam Israr Khan** have been appointed as Returning Officer by the Election Commission vide its Notification No. F.2 (5)2018-Cord dated **31<sup>st</sup> May, 2018** for election to the reserved seats for non-Muslims in the National Assembly.

NOW, THEREFORE, in pursuance of sub-section (3) of section 57 *ibid*, I hereby give Public Notice that following dates have been appointed by the Election Commission for election to the reserved seats for non-Muslims in the National Assembly.

(ii)	Date of publication of names of nominate candidates	08.06.2018
(iii)	Last date for Scrutiny of nomination papers by the Returning Officer	14.06.2018 (Between 0800 hours to 1600 hours)
(iv)	Last date for filing of appeals against decisions of the Returning Officers rejecting/accepting the nomination papers	19.06.2018 (Between 0800 hours to 1600 hours)
(v)	Last date for deciding appeals by the Appellate Tribunals	26.06.2018 (Between 0800 hours to 1600 hours)
(vi)	Date of publication of revised list of candidates	27.06.2018
(vii)	Last date of withdrawal of candidature	28.06.2018 (Between 0800 hours to 1600 hours)

Notice is also hereby given under sub-section (4) of section 57 *ibid* that the nomination papers shall be received by me in the office of Additional Director General (Elections)/ Returning Officer for election to the Reserved Seats for Non-Muslims in the National Assembly between the hours of 08:00 am to 04:00 pm from **04.06.2018** to **08.06.2018**.
