BEFORE THE ELECTION COMMISSION OF PAKISTAN, ISLAMABAD

SUBJECT: OBJECTION PETITION REGARDING THE CONSTITUENCY OF PK-55 MARDAN-VIII, FROM WHICH UNION COUNCIL MIAN ESSA MAY BE EXCLUDED BECAUSE THE SAME IS ADMINISTRATIVE UNIT OF TEHSIL TAKHT BHAI, SIMILARLY U/C GUJAR GARHI MAY ALSO BE EXCLUDED FROM PK-54 BECAUSE THE SAME IS ALSO ADMINISTRATIVE UNIT OF TEHSIL MARDAN.

Sir,

1. That the delimitation of PK Constituency of PK-55 is against the Election Rules and Election Act, 2017, which provides basic principles and guide lines for delimitation, but the delimitation Committee ignored these basic law and rules at the time of preparing /delimitated the above constituency, therefore, the delimitation of PK-55 is not maintainable and is liable to be corrected according to the objection petition.
2. That the U/C Mian Essa is the part and parcel and Administrative Unit of Tehsil Takht Bhai, but this area is included in PK-48 which is against the basic law on the subject, if this area not excluded from PK-48 and not included in PK-55, then the people of the locality would suffer a lot of difficulties in shape of Administration, Revenue and other officials worked having with the Government Departments, the Delimitation Committee included U/C Mian Essa in PK-48 only for Election purposes, therefore, the same Constituency is not according to law, that if through this method, the number of voters exceeds from the limit, then the area of Takkar and U/C Jalala may be excluded from PK-55 and included in PK-54, then the limit would not be affected.
3. That if the area of U/C Mian Essa may not be excluded from PK-48 then it would be created a lot of difficulties in the life standard of the people of the locality, i.e. in shape of work in Education Department, work in Revenue Department, works in Administration, Banks etc., but the Committee have not taken into consideration the physical features

as well as Administrative features and ignored the basic principles for preparation of Constituency, it would be further very difficult for the people of the locality, to approach each departments, cited above.


- 4. That according to the present Constituency, it is impossible for people of locality to communicate each other in Official capacity as well as in their personal capacity, and it would be create hardles/ difficulties in the living of the inhabitants of the area.
- 5. That if the area of U/C Mian Essa excluded from PK-48 and included in PK-55, it would not be disturbed the constituencies.
- 6. That while preparing the delimitation of the constituency of PK-55, the Delimitation Committee ignored the basic requirement, principles, law and Rules and Regulations and also ignored the wishes of the people of the local area, similary the Committee also not investigate and inspected the spot, while preparing the delimitation of PK-55, the Committee also ignored the facilitation and welfare of the peoples of the area.

It is, humbly prayed that the objection petition may kindly be allowed and the Delimitation of PK-55 may be prepared according to the Wishes of the peoples of the locality and also according to the law of land and also ^{in best} interest of justice/
