REPRESENTATION FOR ALTERATION / MODIFICATION IN DELIMITATION OF PP-187 (OKARA-V) AND PP-188 (OKARA-VI) UNDER SECTION 20, 21 & 22 OF THE ELECTION ACT 2017 READ WITH RULE 12, 13 & 14 OF ELECTION RULES 2017, READ WITH ALL ENABLING PROVISIONS OF RELEVANT LAWS

Respected sir,

It is respectfully submitted:

- 1. That the undersigned is a permanent resident of village Dhabi, Patwar circle Ruri, Qanungoi Halqa Kuike Bahawal, Tehsil Depalpur District Okara and is a registered voter of the said village, currently falling in the newly delimited PP-188 (Okara-VI) and NA- 143 (Okara-III) (Annex-A)
- 2. That the undersigned is aggrieved by the new delimitation of PP-188 (Okara-VI) on the following grounds

GROUNDS

I. That the new delimitation of PP 187 (Okara-V) and PP 188 (Okara-VI), as published in preliminary report and preliminary list has been done on the basis of incorrect map provided by the revenue authorities which has shown the patwar circles of Ruri and Sahaba Wala at locations other than their actual ones. The petitioner has already submitted a separate application for correction of map. (Annex-B).

II. That the incorrect map has led to lopsided delimitation of the two constituencies of PP-187 and PP-188.

III.

- That the distribution of population between the two provincial assembly constituencies of PP 187 (Okara-V) and PP- 188 (Okara-VI) is highly disproportionate which runs counter to the provisions of Section 20 of Election Act 2017 which requires regard and consideration of distribution of population. Population of PP 187 (Okara-V) is **366966** persons whereas population of PP 188 (Okara-VI) is **384622** persons. Population needs to be rationalized, as far as possible, by inter-constituency transfer of patwar circles which are geographically compact with the concerned constituencies.
- IV. That the inclusion of Patwar circles Ruri, Bhawan Mnazbta & Additional Bhawan Manzabta and Sahaba Wala & Additional Sahaba Wala of QH Kueki Bahawal in PP-188, is against the principle of "facilities of communication and public convenience and other cognate factors" as enunciated in Section 20 of the Election Act 2017 on the grounds that these patwar circles are geographically compact with the areas included in PP-187 in terms of means of communication / roads, agri-markets etc
- V. That the inclusion of Patwar circles Kalasan Hamid, Asadullah Garh and Puran of QH Basirpur in PP-187, is against the principle of "facilities of communication and public convenience and other cognate factors" as enunciated in Section 20 of the Election Act 2017 on the grounds that these patwar circles are geographically compact with the areas in PP-188 in terms of means of communication, roads etc.

PROPOSALS

3. That on the grounds mentioned above, redistribution / re-adjustment of population by inter-constituency transfer of patwar circles is proposed as under:

- Following patwar circles of PP-188 are proposed to be transferred to PF 187 (Okara-V)
 - a. Patwar circle Ruri
 - b. Patwar circle Sahaba Wala along with additional Sahaba Wala
 - c. Patwar circle Bhawan Manzabta along with additional Bhawan Manzabta
- ii. Following Patwar circles of PP-187 are proposed to be transferred to PP-188
 - a. Patwar circle Kalasan Hamid
 - b. Patwar circle Asadullah Garh
 - c. Patwar circle Puran

PRAYER

4. It is prayed that, for the purposes of compactness of constituencies, ease of communication and public convenience, following delimitation of PP-187 (Okara-V) and PP-188 (Okara-VI) may very graciously be ordered:
