Subject: **OBJECTION PETITION REGARDING NEW CONSTITUENCY**

Sir, Respectfully Sheweth:-

1. That brief facts giving rise to file the instant objection petition on behalf of the petitioner before this office are that the petitioner is residing at Qilla Sahib Singh Tehsil and District Sheikhupura which was under the previous constituency of NA-133 from the year 2000 to 2018.
2. That the petitioner is the voter member at serial No. 30 Block Code No. 197030806 of previous Constituency NA-133 in which Municipal Committee Sheikhupura, QH Sheikhupura, QH Baharianwala, QH Kot Pindi Das and QH Abu-Al-Khair were included.
3. That now the previous constituency has totally been changed and new constituency has been passed by the Election Commission of Pakistan and according to new constituency NA-133 has been changed into NA-121 and the following areas are including therein:-

- ii. QH Sheikhupura
 - iii. Two PC namely Sahoki Mallian and Jewan Pura Kalan of QH Baharianwala.
 - iv. QH Jandiala Sher Khan
 - v. QH Ajnianwala

It is pertinent to mention here that in new constituency, previous areas of NA-133 have also been excluded i.e. some PC of QH Baharianwala, QH Kot Pindi Das and QH Abu-Al- which is against the facts and ground reality.

4. That according to new constituency NA-119 is comprising upon the population of 8,85,990/-, NA-120 based upon 8,42,144/- population, NA-121 based upon 9,19,756/- population and NA-122 is based upon 8,12,536/- which are totally different in population wise from each other.
5. That QH Ajnianwala was previously the part of NA-134 but now it is the part of NA-121 and distance between NA-121 and District Head Quarter is about 40 Kilometer, due to this reason people will be faced more problems in casting their votes, that's why the QH Ajnianwala is liable to be transferred at its previous position, otherwise the people will suffer an irreparable loss.
6. That it is pertinent to mention here that four PCs of QH

Wala and Gazi Androon which are now in the constituency of NA-120 which was previously under the constituency of NA-133 and this areas are attached with city but due to the new constituency, they get on boundary line of NA-120 which is not in the preference of candidates. That's why these are liable to be shifted to previous location, which is necessary for the sake of justice, equity and fair play.

7. That it is pertinent to mention here that new constituency has been made out on the instigation of federal minister and local MNA just to get ulterior motives and pre-pole rigging.
8. That a great miscarriage of justice has been occasioned to the petitioner due to passage of the new constituency.
9. That the petitioner has no other adequate, efficacious and speedy remedy except to invoke the extra ordinary constitutional jurisdiction of this office.
10. That proposed list of new constituencies of NA-119 to 122 are attached herewith for kind your consideration as **Annexure "A"**.

PRAYER

Under these circumstances; it is therefore respectfully prayed that the instant objection petition may kindly be accepted and following remedies may also been awarded to the petitioner:-

- ii. That QH Ajnianwala was previously the part of NA-134, presently is the part of NA-121 and distance between NA-121 and District Head Quarter is about 40 Kilometer, due to this reason the QH Ajnianwala may kindly be transferred/shifted at its previous position.
- iii. That four PCs of QH Baharianwala namely Kahnianwala, Muraday Kalan, Mudd Wala and Gazi Androon which are now in the constituency of NA-120 may also kindly be shifted to previous location i.e. NA-121.

Any other appropriate relief, which this office deems fit and proper to the circumstances of the petitioner, may also be awarded.
