PRELIMINARY LIST OF CONSTITUENCY
NA-122, SHEIKHUPURA.

Sir, Respectfully Sheweth:

1. That the petitioner is resident of Village Mirza Virkan, Post Office same, Tehsil and District Sheikhpura, having CNIC No.35404-8797770-3, registered voter in Union Council No.50 Mirza Virkan, Shumariati Block Code 197020607, and is registered voter at serial No.231 in voter list of Jahangirpura. (Copy of CNIC and voter list are attached).
2. That the constituencies of National Assembly has been de-lemmatized and with following numbers list has been issued as preliminary list:
 - i) NA-119, Sheikhpura.
 - ii) NA-120, Sheikhpura.
 - iii) NA-121, Sheikhpura.

iv) NA-122, Sheikhpura.

3. That the petitioner is aggrieved by the new delimitation and seeks proposed delimitation in NA-121 Sheikhpura-iii and NA-122 Sheikhpura-iv, without bringing major changes in both the constituencies of Sheikhpura under following amongst the others

GROUND:

1. That the new delimitation is published in preliminary report and preliminary list is against the provisions of section 20 of the Election Act, 2017 read with rule 10 and 12 of the Election Rules 2017.
2. That our constituency of Ajnianwala, Jandiala Sher Khan Qanungois have been wrongly and unnaturally included in the area of NA-121 Sheikhpura-iii.
3. That our constituency of Ajnianwala and Jandiala Sher Khan Qanungois, have natural relations and part of with area of NA-122 Sheikhpura-iv from last about 15 years.
4. That due above said illegal and unnatural new delimitation about Rs.1,00,000/- votes have been

decreased in NA-122 Sheikhpura-iv, which require kind interference of your goodself.

5. That our constituency of Ajnianwala and Jandiala Sher Khan Qanungois have been added / included and are made part of the constituency of NA-121 Sheikhpura-iii, which were never been part of the same since the last delimitation done in 2002. Further it is in violation of the principles that old constituencies must not be disturbed much. The following areas have been wrongly added in NA-121 Sheikhpura

- a) Q.H Ajnianwala (79053)
- b) Q.H Jandiala Sher Khan (122547)
- c) TC (old) Jandiala Sher Khan (11821)

8. That Population in NA-122 Sheikhpura by including Tehsil Safdarabad is 272500, MC Farooqabad 77706, QH Farooqabad 152004, HQ Ajnianwala 79053, QH Jandia, Sher Khan 122547, TC old Jandiala Sher Khan 11821 and the following Patwar Circles of QH Sheikhpura:

And as per proposal total population of NA-122 Sheikhpura would be 8,18,746.

9. That the delimitations of both constituencies have not been done as mentioned in rule 10(5) of the Election Rules 2017 according to which the delimitation of constituencies of an assemblies shall start from the Northern end of the district, or, as the case may be, the agency and then proceed clock wise in zigzag manner keeping in view the population among the constituencies of the an Assembly shall remain as close as may be practicable to the quota. Hence the requirement

of law has been overlooked in the delimitation process done by the commission.

10. It is a settled law that census circles should not be divided and broken affecting the basic boundaries of the constituencies, whereas, the same has been done against the procedure defined by law.

11. That as per new delimitation structure the distribution of population has been geographically compact area of facilitating communication and road approached with the object for public convenience, whereas the same has been overlooked in the process of delimitation. Hence, a suggested proposal is forwarded for the delimitation of NA-122 Sheikhupura-iv keeping in view the requirements of the law.

PRAYER

In view of the above submissions it is respectfully prayed that proposed alteration may kindly be accepted and NA-121 Sheikhupura and NA-122 Sheikhupura boundaries may kindly be adjusted as

Any other appropriate relief which this Hon'able
Court deems fit and proper to the circumstances
of the petition, may also kindly be awarded.
