3- That the above areas were the part and parcel of PP 145 but those area were wrongly inducted in PP146 which has created great difficulties for the people of PP 145 as the above said areas are falling in the same vicinity and this delimitation will cause damage to the people and will create hurdle in development works in the area in future. And some streets and bazaars were inducted in PP 145 and some streets have been inducted in PP 146.

Under these circumstances it is therefore prayed that the above areas may kindly be inducted in PP 145 instead of pp 146 Lahore.
