CONSTITUENCY PP- 157 LAHORE VII

Respectfully sheweth,

- 1 That the petitioner is voter of Old NA-122 & PP-147,  
New NA-124 & PP-147
- 2 As per notification No. F 8(3)/2018-sec- 1 Dated 5-3-  
2018 under section 21 (3) Election Act 2017 read with  
rule 12 of Election rules 2017 regarding publication of  
preliminary report and list of constituencies of all the  
provinces. The whole constituency has been changed and  
population divided amongst the different constituencies  
which is injustice with the population of my  
constituency.
- 3 That the undersigned is aggrieved by the new  
delimitation and seeks proposed delimitation without  
bringing major changes in both the constituency.

## Facts and Reasons

- 1 That while formulating the delimitation proposal the principal as laid down in section 20 of the Act. 2017 to some extent seem to be over looked.
- 2 Prima facie it appears that distribution of population was kept in view rather compactness of area, facilitation of public convenience and cognate factors to ensure homogeneity in creation of constituencies.
- 3 As per new delimitation few areas have been added by ignoring the principal that old constituency should be less disturbed.
- 4 That the population required as per quota could be retained with adjusting minor changes.
- 5 The following census charges were added in PP- 147 and PP-154 Lahore which never have been part of said constituency.
  - a) Charge No. 13 excluding Circle 1
  - b) Circle No. 4 & 5 of Charge No. 14
  - c) Charge No.15 excluding Circle No. 1
  - d) Charge No. 16

6. That by adjusting charges as mentioned in para V required population as per census 2017 would not be disturbed and remain within the prescribed limit.

7. Variation of total population of involved constituencies comes to is given below:

8. The constituencies is slightly over the prescribed quota because of the fact that the administrative unit of charge has been kept intact. Hence, suggested proposal is submitted for the delimitation of PP-157 keeping in view of the relevant law/rules.

- iii) Charge No. 15 excluding Circle No. 1 (addition)
- iv) Charge No. 16 (addition)
- v) Charge No. 34 excluding Circle 3
