### OBJECTION PETITION / REPRESENTATION

under Section 21(3) of the Election Act 2017 read with Rule 12 of the Election Rules  
2017, against the Impugned Delimitation of the Constituencies of District Lahore:  
NA-127 Lahore – V; and NA-124 Lahore - II.

The petitioner respectfully submits as under:

1. The petitioner being a resident and registered voter of District Lahore is entitled to object to the Preliminary Delimitation of the Constituencies of NA-127 Lahore – V and NA-124 Lahore – II of District Lahore. Copies of the CNIC and Voter Certificate are ANNEX - A.
2. The petitioner is aggrieved of the Preliminary Delimitation carried out by the respondent Delimitation Committee. Hence, this objection petition / representation.
3. The petitioner's proposal with justification in support of his objection are as follows:

## **SUGGESTIONS / PROPOSAL**

### **Areas Proposed to be Excluded from NA – 127 Lahore – V and to be Included in NA – 124 Lahore – II:**

- a. Following Charge of Lahore Shalimar Tehsil:
  1. Charge No. 4
- b. Following Circle of Charge No. 5 of Lahore Shalimar Tehsil:
  1. Circle No. 2

### **Areas Proposed to be Included in NA – 127 Lahore – V after Exclusion from NA – 124 Lahore – II:**

- a. Following Charges of Lahore Shalimar Tehsil:
  1. Charge No. 13; and
  2. Charge No. 15.

## **JUSTIFICATION:**

1. Charge No. 4 of Tehsil Shalimar has been proposed to be included in NA-124 by excluding from NA-127 so that Bhogiwal Road should become a boundary of both the NAs, as the said charge is also geographically compact with NA-124.
2. Circle No. 2 of Charge No. 5 of Shalimar Tehsil District Lahore has been proposed to be included in NA-124 after excluding from NA-127, so that the whole area of Singhpura should remain in one the same constituency having natural geographical compactness, instead of being unwarrantedly splitted into two different constituencies.
3. Charges No. 13 & 15 of Tehsil Shalimar Lahore District have been proposed to be excluded from NA-124 and to be included in NA-127 which has geographical compactness with charge No. 14 & 16 of NA-127 as well as to ensure that the whole area of Railway Carriage Shop & Garhi Shahu should

remain in one constituency, instead of being unwarrantedly splitted into two different constituencies.

4. By the proposed mutual inclusion and exclusion, the total Population of NA – 124 Lahore – II would slightly enhance from 801,410 to 804,371, whereas, the total Population of ~~NA~~ – 127 Lahore – V, would be slightly reduced from 819,049 to 816,088, hence the district quoto would not affect.
5. By the proposed mutual inclusion / exclusion both the Constituencies of NA-124 and NA-127 would become homogeneous due to distribution of population in geographically compact areas, physical features, existing boundaries of administrative units, facilities of communication and public convenience and other cognate factors.

4. That if the petitioner's proposal is not accepted and the preliminary delimitation is not amended, revised / modified, the petitioner shall also suffer irreparable loss.

#### PRAYER:

It is respectfully prayed that the Preliminary Delimitation of the Constituencies of NA-127 Lahore – V and NA-124 Lahore - II of District Lahore, may please be amended, altered, and modified as proposed by the petitioner.

Any other relief which the petitioner is found entitled may please also be granted.
