- 2. 49/3R
- 3.52/3R
- 4. 42/3R
- 5. 46/3R
- 6. 40/3R of District Okara.

Now while preparing the map of District Okara by the Election Commission of Pakistan NA144 Okara-IV of District Okara is demarked as NA 141 Okara-1.

- 4. That while preparing proposal for delimitation of constituency of the national assembly section 10, sub section (5) of Election Act 2017 has been clearly violated a north end of the district Okara is Chuchak QH which is within the limits of Tehsil Renala Khurd. Tehsil Renala Khurd consists of four QH's
 - 1. Chuchak
 - 2. Akhtarabad
 - 3. Renala-1
 - 4. Renala-2

And Renala Muncipal Committee. So the total population of tehsil Renala Khurd is 4,58,572 while the tehsil Renala Khurd needs population of 3,10212, adjoining QH with Tehsil Renala Khurd is QH of Kohla District Okara having the population 1,02,725, Satghara QH of District Okara population 1,43,631 while the Okara City-2 QH, adjoining PCs with NA 141 as well as with Tehsil boundry of Renala Khurd are 49/2L having population 26,346 and Chak No 54/2-L PC having population 36461 completes the constituency's population while previously the above said PC was also in the NA's constituency of Tehsil Renala Khurd as well. So, the population of the constituency becomes 7, 67,767.

5. That the presently proposed constituency 141 according to election commission map is against the section 10, subsection (5) and section 20, sub section (1) of the election Act 2017.
