- 1. The representator/ petitioner is resident and voter of NA-148 district Sahiwal-II, Punjab, Pakistan. Voter certificate is hereby is attached as 'ANNEX' 'A'.
- 2. District Sahiwal is delimited/divided into three constituencies i:e NA-147, NA-148, NA-149 for the purpose of general election of National Assembly of Pakistan 2018. The marked map of above mentioned constituencies of district Sahiwal is hereby is attached 'ANNEX' 'B'. Detail of Q.H. and Pe. as Anax. "C'
- 3. The representator/ petitioner submits representation on NA 148, Sahiwal II, on the following grounds.

Grounds

- (i) There is gross miscarriage of geographical compact areas in distribution of population, physical features, facilities of communication and public convivences.
- (ii) The PCs 102/9L, 96/9L, 97/9L of Sahiwal QH which are included in NA-149 Sahiwal-III according to proposed preliminary list have no geographical compact with NA-149 Sahiwal-III. Therefore, these PCs should be excludes from NA-149 and include NA-148.
- (iii) The PCs 20/11L and 164/9L of Gaziabad QH historically, physically, and geographically have no concern with NA-147 Sahiwal-I. Therefore, these PCs should be excluded from NA-149 and included into NA-148.
- (iv) The above-mentioned PCs and proposed areas of NA-148 Sahiwal-II other than 90/9L remained together in one constituency prior to 2002.
- (v) The representator/ objector proposed the constituencies of National Assembly of District Sahiwal in the following manner which are quite natural, geographically
