Respectfully Sheweth;

1. That the petitioner is a voter member of the constituency of NA-177, Rahim Yar Khan-III.
2. That vide notification No. F8(3)/2018-Elc-I dated 5th March 2018. Honourable Election Commission of Pakistan was pleased to publish, in official Gazette, for information of general public, preliminary report and the list of the constituencies in respect of National Assembly and Provincial Assemblies.
3. That the petitioner being aggrieved and seeks amendment of delimitation of constituency NA-177, Rahim Yar Khan III inter alia on the following

GROUND

1. That the new delimitations as published in preliminary report and list defy the provision of section 20 of the Election Act, 2017 and rule 10 and 12 of the Election Rules 2017.
2. That the constituency No. NA 177-III has been delimitation in utter disregard to distribution of population in geographically compact area, physical features, existing boundaries of administrative units, facilities of

communication and public convenience and other cognate factors to ensure homogeneity in the creation of constituency.

3. That according to the notification the existing NA 177-III constituency consists of following QHs of District Rahim Yar Khan.

(b) That from 1988 to 2002 Rahim Yar Khan District consists of four constituencies of National Assembly. In 2002 two new constituencies created, now after this delimitation number of constituencies have not been increased or decreased.
