

The instant representation if filed by duly authorized attorney of the Petitioners.

FACTS & GROUNDS:

- 1. That, the NA-242 is a part of District East, Karachi, which as per the notified Census results, has a population of 7,34,410 people of District East as per Notification No. F.8(3)2018-Elec-I, dated:5th March 2018 of ECP.
- 2. That Na-242 consists of 02 PS, i.e. PS-99 and PS-100. As per population and compacted area the NA-242 is made by ECP perfectly, where we have no objection on this NA-242.

- 3. That, the NA-243 is a part of District East, Karachi, which as per the notified Census results, has a population of 6,955,88 people of District East as per Notification No. F.8(3)2018-Elec-I, dated:5th March 2018 of ECP.
- 4. That, NA-243 as per ECP consists of PS-101 complete, PS-102 (part) and PS-103(Part). 03-04-18
- 5. That, NA-243 can be formatted on PS-101 and PS-102, whose population is 6,99,470, as 02 PS will be more convenient for public and will be more convenient for the voters.
- 6. That, the NA-244 is a part of District East, Karachi, which as per the notified Census results, has a population of 7,26,253 people of District East as per Notification No. F.8(3)2018-Elec-I, dated:5th March 2018 of ECP.
- 7. That, NA-244 consists of 03 PS i.e. PS-103(Part), PS-105(Part), PS-106(complete).
- 8. That, NA-244 can be merged together as PS-103 and PS-106 and resultantly it will become a fruitful NA for the public at large.
- 9. That, the NA-245 is a part of District East, Karachi, which as per the notified Census results, has a population of 6,97,365 people of District East as per Notification No. F.8(3)2018-Elec-I, dated:5th March 2018 of ECP.
- 10. That, NA-245 consists of 03 PS, i.e. PS-102(part), PS-105(part), PS-104(full).
- 11. That, PS-104 and PS-105 can be merged and NA-245 can be formatted in a better way, because 01 NA consisting of 03 PS, and it is creating a huge difficulty for public at large.
- 12. That, at this juncture it is imperative to point-out here that above arrangement proposed by the Petitioners follows the criteria enunciated in the Elections Act and Rules of 2017. Needless to state that the proposed arrangement will not only save irrational distribution also make the constituency more compact without changing geographical status.

<u>PRAYER</u>:

It is therefore most respectfully submitted that the Hon'ble Election Commission of Pakistan may be pleased to set aside the preliminary delimitation of constituencies of National Assembly's in respect of NA-242, NA-243, NA-244, NA-245 in the interest of justice, accept the proposal submitted by the petitioners as a final list of constituencies in respect of NA-242, NA-243, NA-244, NA-245.
