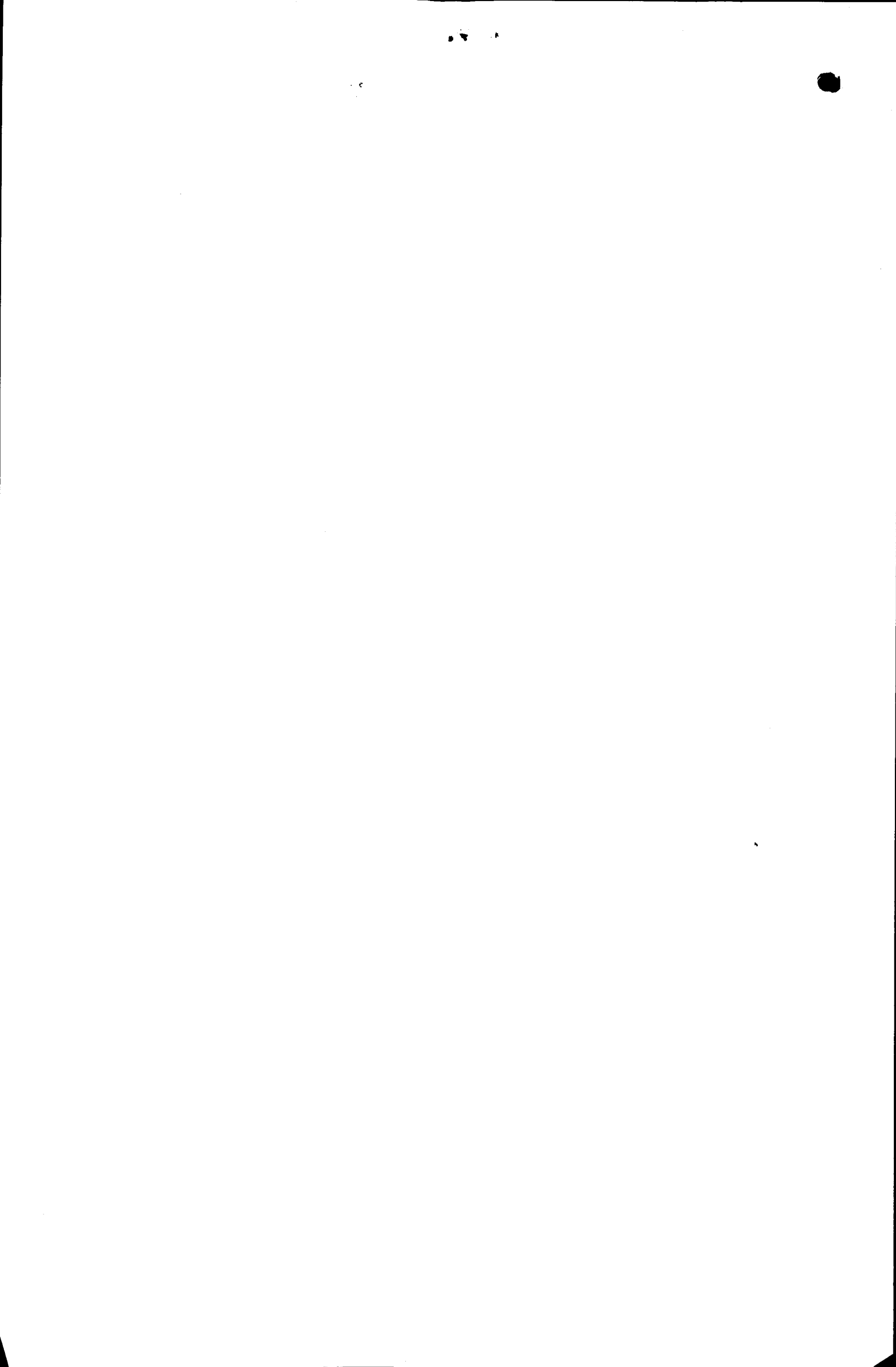

Subject: OBJECTIONS REGARDING DELIMITATION OF CONSTITUENCY NA-269 KHUZDAR, BALOCHISTAN.

R/Sir,

1. That applicant is permanently residing in District Khuzdar since his forefather and is retired Doctor belonging from Constituency of NA-269 Khuzdar. At the very outset it is submitted that in present delimitation 16 villages i.e (1) Mir Gul, (2) Garangh, (3) Chaboon, (4) Dhadaro, (5) Dasht Luck, (6). Ghatay Soor, (7) Kehra, (8) Kachando, (9) Kircha, (10) Karang, (11) Mati Wala Chacha, (12) Chota Phoor, (13) Tohta, (14) Shook Bargh, (15) Waidah, (16) Kohri of Union Council Sunchako Sub Tehsil Karkh District Khuzdar NA-269 have been included in NA-203 Kumber Shadadkot Sindh. It is important to mention here that present delimitation of NA-269 has been carried out without any justification perusal of record and Census of 2017.

It is imperative to mention here that in Census 2017, the people and house of above said villages were counted as the population of Sub Tehsil Karkh District Khuzdar, but astonishingly while making the delimitation of NA-269, the above said villages of Union Council Sunchako Sub Tehsil Karkh District Khuzdar NA-269 were included in District Kumber Shadadkot Sindh by crossing the boundaries of

Province of Balochistan, which is an unjustifiable act, because beside the Census 2017, the above said Villages are the part of Sub Tehsil Karkh District Khuzdar, because according to settlement of 1975, the said 16 villages of Union Council Sunchako Sub Tehsil Kirkh District Khuzdar are the part of Tehsil Karkh Khuzdar. The same can easily be perused from the old Map of District Khuzdar, moreover after transferring the said villages in the area of Kumber Shadadkot NA-203 named as Kohistan, no detail has been shown in the Map of Kumber Shadadkot regarding the villages in question. The said villages have been included in the NA-203 Kumber Shadadkot Sindh by extending the limits of boundaries of Sindh, because due to illegal extension of limits of Province of Sindh the villages in question are included in NA-203 Kumber Shadadkot by excluding the same from NA-269 Khuzdar Balochistan. The villages in question could not be excluded from the NA-269 Khuzdar Balochistan, because the people of the said constituency are having same social status in short they are realistically, linguistically, racially and rationally equal. Copies of List of villages, result of Census 2017, application, Map and documents of ownership are attached.

2. That there is some other facts, which may prove that the Villages in question as mentioned above of Union Council Sunchako Sub Tehsil Karkh District Khuzdar NA-269 are the part of Sub-Tehsil Karkh District Khuzdar Balochistan. As the District Education Officer Khuzdar through Verification

Certificate dated 01-03-2017 verified that Government Primary School Dhadaro is situated in Union Council Sunchako Sub Tehsil Karkh District Khuzdar, Balochistan which is proving that village Dhadaro is the part of Sub Tehsil Karkh District Khuzdar NA-269. Moreover through Certificate dated 27-02-2017 the Member of Union Council Dhadaro verified that village Dhadaro is situated within the limits of District Khuzdar. Further from the Union Council Sunchako Sub Tehsil Karkh there is Elected Chairman Union Council.

Besides, the Tehsildar Karkh also issued list of farmers which is showing the name of villages, land owners and area which is another prove that the villages in question as mentioned above are parts of Union Council Sunchako Sub-Tehsil Karkh District Khuzdar, but have wrongly been included in NA-203 Kumber Shadadkot. Further when through an Community Development Programme meant only for the Province of Sindh a Water Tank was started to be constructed in "kuty Ji Kabar", the Deputy Commissioner Khuzdar on the application of the inhabitants of "kuty Ji Kabar" took action regarding the construction of Water Tank as the same was constructed by said Community Development Programme by crossing the limits of Sindh in the territory of Balochistan without fulfilling formalities.

There is an other important aspect due to which it could be easily be imagine that inclusion of above said villages in



*Kumber Shadadkot Sindh is without any lawful basis, because in 2013 Election the people of Union Council Sunchako Sub Tehsil Karkh, District Khuzdar including the villages in question cast their votes to the candidate of District Khuzdar according to list of Polling Stations and Map showing the route issued by the Naib Tehsildar Khuzdar. Further the present delimitation of NA-269 and NA-203 is illegal, as the areas of one province could not be included in other province, because due to said delimitation unrest has been development amongst the people of District Khuzdar NA-269.*

3. *The delimitation of constituencies is the exercise of redrawing boundaries of Parliamentary Constituencies to maintain equitable parity distribution. Electoral constituency boundaries should be drawn so that constituencies are relatively equal which may allow voters to have an equally weighted vote in the election of representatives. Moreover the principles are to the effect that all constituencies shall as far as practicable. Delimited having regard to the distribution of population in geographically compact areas existing boundaries of administrative units. Facilities of communication and public convenience and other cognate factors of ensure homogeneity in creation of the Constituencies.*

*From all above it is concluded that people/voters as well as candidates are not happy from the exclusion of villages i.e (1) Mir Gul, (2) Garangh, (3) Chaboon, (4) Dhadaro, (5) Dasht*
