REPRESENTATION

UNDER SECTION 21(3) OF THE ELECTION ACT, 2017 READ WITH RULE 12 OF THE ELECTION RULES, 2017 AND ALL OTHER ENABLING PROVISION OF LAW

AGAINST PRELIMINARY REPORT IN RESPECT OF CONSTITUENCIES OF DERA ISMAIL KHAN – I (NA-38) AND DERA ISMAIL KHAN – II (NA-39)

The petitioner very humbly submits as under:

1. That the petitioner is resident of Dera Ismail Khan (D.I. Khan) and is a bona fide registered voter of Patwar Circle Pota, Kanungo Circle Chahkan, Tehsil & District D.I. Khan having Sr.



(Copy of NIC of the petitioner is attached as Annexure A)

- 2. That prior to the delimitation of proposed two constituencies i.e. NA-38 and NA-39, the District D.I. Khan and District Tank had two constituencies i.e. NA-24 and NA-25. NA-24 was comprising all area of Tehsil D.I. Khan except Patwar Circle Giloti; some area of Tehsil Paharpur; and Tehsil Parova while some area of Tehsil Paharpur; Patwar Circle Giloti; Tehsil Kulachi; Tehsil Daraban; and District Tank were included in NA-25.
- 3. That it is a matter of record that as per the recent official census, the total population of D.I. Khan is 1,627,132. This hon'ble Commission proposed new delimitation of the said constituencies *vide* its Notification No. F.8(3)/2018-Elec-I dated 05.03.2018 whereby the previous constituencies of NA-24 and NA-25 have been changed in a manner that the whole District Tank has been delimited as one constituency i.e. NA-37 while District D.I. Khan has been divided into two constituencies i.e. NA-38 and NA-39 with the following areas therein:

NA-38 (D.I. Khan – I):

(a) Paharpur Tehsil;

- (b) The following Kanungo Halqas of Tehsil D.I. Khan:
 - i. Yarik Kanungo Halqa; and
 - ii. Shorkot Kanungo Halqa
- (c) D.I. Khan Kanungo Halqa of D.I. Khan Tehsil, excluding the following Patwar Circles:
 - i. Kotla Saidan; and
 - ii. Dhap Chabak.
- (d) Census Charge No.05 (MC D.I. Khan); and
- (e) Census Charge No.1 (D.I. Khan Cantonment)

NA-39 (D.I. Khan - II):

- (a) The following Kanungo Halqas of D.I. Khan Tehsil:
 - i. Chahkan Kanungo Halqa; and
 - ii. Muryali Kanungo Halqa.
- (b) The following Patwar Circles of D.I. Khan Kanungo Halqa of D.I. Khan Tehsil:
 - i. Kotla Saidan; and
 - ii. Dhap Chabak.
- (c) The following Tehsils of D.I. Khan District:
 - i. Parova;
 - ii. Daraban; and
 - iii. Kulachi.
- 4. That the population has been shown in the said notification as 818,254 in NA-38 and 808,878 in NA-39.
- 5. That the said delimitation of both constituencies is against the principles of delimitation of constituencies as envisaged in section 20 of the Election Act, 2017 read with the Election Rules, 2017. Needless to state that under the said provisions of law, this hon'ble Commission, while delimiting the constituencies, has to give regard to the following to ensure homogeneity:

- a. Distribution of population in geographically compact areas;
- b. Physical features;
- c. Existing boundaries of administrative units;
- d. Facilities of communication and public convenience; and
- e. Other cognate factors.
- 6. That the proposed delimitation requires modifications/amendments in accordance with the letter and spirit of law and in this regard, the following specific objections thereto may kindly be considered:
 - a. As per rule 10(5) of the Election Rules, 2017, the delimitation of a constituency should start from the Northern end of the District and then proceed clock-wise in a *zigzag* manner keeping in view that population among the constituency shall remain as close as may be practicable to the quota. This principle has not been applied appropriately in respect of NA-38 and NA-39.
 - b. The cultural, social and geographical aspects of the delimitation have also not been given due consideration. It is to be noted that previously, Tehsil Kulachi and Tehsil Paharpur (excluding city area) were together in NA 25 and they have been so for the last two decades. Now, in the proposed delimitation, Kulachi is placed in NA 39 while Paharpur in NA 38.
 - c. That the economically stable and developed areas have been grouped together in NA-38 which is quite unreasonable. It can be seen that Tehsil Paharpur, D.I. Khan Kanungo Halqa of D.I. Khan Tehsil (excluding Patwar Circles Kotla Saidan and Dhap Chabak) and MC D.I. Khan are in the proposed delimitation of NA-38. On the other hand, NA-39 includes rural, economically unstable and far flung areas. It is to be noted that previously half of the rural areas were adjoined with Paharpur Tehsil whereas half were with D.I. Khan Tehsil due to which the said rural areas were benefited.
 - d. As per the proposed delimitation, NA-38 comprises one-third (1/3rd) of the total land area of the D.I. Khan District while two-third (2/3rd) of the said area belongs to NA-39. This itself evidently shows that the relevant rules have not been complied with and clock-wise *zigzag* method of delimitation has not been strictly followed.
 - e. That maximum regard in law has been given to the administrative units while adopting the manner of clock-wise zigzag manner.
