REPRESENTATION U/S 21 OF THE ELECTIONS ACT 2017 READ WITH RULE 11 OF THE ELECTION RULES 2017 AGAINST PRELIMINARY DELIMITATION OF TERITORIAL CONSTITUENCY OF NA-106 FAISALABAD-VI.

Respectfully Sheweth;

- That the applicant/objector is a voter member of the constituency of NA-106, Faisalabad-VI. The relevant portion of voter list/certificate of vote from the concerned office is annexed herewith.
- 2. That the applicant/objector is aggrieved by the preliminary delimitation of territorial constituency of NA-106, Faisalabad-VI (hereinafter to be referred as "impugned delimitation") and seeks its modification inter-alia on the following;

## **GROUNDS**

- i) That the impugned delimitation as published in preliminary report and preliminary list is against the letter and spirit of the law.
- ii) That NA-106, Faisalabad-VI has been delimited in such a way that QH of Faisalabad Saddar Tehsil Thikriwala has been

included as a whole, whereas its PC 246 comprising of Chaks 241, 245, 246 and 247 RBs are to be excluded and are to be made part of NA-105 Faisalabad-V. They have been included in NA-106, Faisalabad-VI out of way. The census charges of Faisalabad MC bearing charge No. 49 and 50 (presently part of NA-105, Faisalabad-V) and charge No. 51 (presently part of NA-109, Faisalabad-IX) are to be included in NA-106, Faisalabad-VI in place of PC 246 mentioned above. The railway line divides PC 246 of Thikriwala and rest of the constituency of NA-106, Faisalabad-VI. The major portion of boundary of charge No. 51 abuts and connects with the area of NA-106, Faisalabad-VI. By above proposal road network, administration and public convenience will become better and the homogeneity in creation of constituencies will be ensured.

- iii) That a suggested proposal is forwarded for the delimitation of NA-106, Faisalabad-VI, keeping in view the requirements of law. The proposed delimitation of NA-106, Faisalabad-VI is as follows:


