and as per site plan of delimitation, charge No. 26 consisting upon union councils NO. 49, 50 and U.C 48 half has been wrongly included in constituency of PP-117 against ground reality and is equitably and rationally deserves to be included in constituency of PP-112.

- **b.** That charge no. 26 is purely and rationally out of approach through any kind of mettled road on the ground that charge no. 26 is separated through Main railway line leading towards Lahore, Sangla and Rawalpindi and even there is no possibility of pedestrian approach of constituency of the people of locality of charge no. 26 in PP-117.
- c. That even otherwise previously constituency PP-112 was in shape of a compact block including charge no. 26 and said compact block was made keeping in view the convenience of the public of the locality of charge no. 26 and most of the people has also links and relations with the people of PP-112, hence preliminary delimitation of constituency of PP-117 is not justified as per aforesaid ground reality and location of the charge no. 26.
- **d.** That previously delimitation of PP-117 and PP-112 was made on the basis of above said compact block i.e partitioned through main railway line and said

delimitation was made keeping in view the interest of the people of the locality and political affiliation of

- **f.** That in case of inclusion of charge no. 26 total no. of votes will not be disturbed materially and in the large interest of justice, equity, fair play and convenience of the public of charge no. 26 ought have to be included in constituency of PP-112.
- g. That people of charge no. 26 has die heart and old standing affiliation with the constituency of people of PP-112 and in connection with solution of their problems and in order to make their representation though representative of PP-112, people of charge no. 26 always feel comfortable to remain part of previously delimitation of constituency of PP-112, hence, restoration of charge no. 26 in delimitation in constituency of PP-112 is justified rather requirement of ground reality also.
- **h.** That if charge no. 26 is not included in constituency of PP-112, petitioner and public at large of charge no. 26 shall suffer an irreparable loss and injury and even the facts and circumstances stated above also demand the inclusion of charge no. 26 in constituency of PP-112.
