Respectfully Sheweth:-

1. That vide notification No. F8(3)/2018-Elc-I dated 5<sup>th</sup> March 2018, Honourable Election Commission was pleased to publish, in official Gazette, for information of general public, preliminary report and the list of constituencies in respect of National Assembly and Provincial Assemblies.
2. That the petitioner Abdul Rehman son of Gaji resident / Voter of Chak No. 184-G.B. Tehsil and District Toba Tek Singh which include in NA-112 Toba Tek Singh-II.

3. That the petitioner being aggrieved seeks amendment / alteration of delimitation of constituencies of NA-112 & NA-111 of Toba Tek Singh District inter alia on the following g:

**GROUND**

- a. That the new delimitations as published in preliminary report and preliminary list defy the provision of section 20 of the Election Act, 2017 & The Rule 10 & 12 of the Election Rules 2017.
- b. That the constituencies Nos. NA-111 & NA-112 have been delimitation in utter disregard to distribution of population in geographically compact areas, physical features, existing boundaries of administrative units, facilities of communication and public convenience and other cognate factors to ensure homogeneity in the creation of constituencies.
- c. That according to the notification the existing NA-112 constituency consist of following QHs of District Toba Tek Sigh:

f. That proposed alteration in delimitation of constituencies NA-112 & NA-111 are just, proper and necessary for the following:

**REASONS**

- a. The delimitations have not been made in accordance with the manner, provided by Rule 10(5) of the Election Rules 2017 according to which delimitation of constituencies of an Assembly shall start from northern end of District and then proceed clockwise in a zigzag manner keeping in view population of the constituency.

- b. That according to proposed amendment the area excluded from NA-112 and included in NA-111 i.e. PCs 375/JB of Toba-II QH of Tehsil Toba Tek Singh is consisting of only population 6414 and as per new proposed delimitation structure, the distribution of population among all the constituencies of district have be geographically compact area
- c. The existing delimitation of constituencies of NA-112 and NA-111 has been made in is clear violation of Rule 10(5) of the Election Rules 2017, because the population among the constituencies shall not remain as close as may be practicable and after the alteration the population shall be remain as close as may be practicable.
- d. That since 1988 to up till now this PC i.e. PCs 375/JB of Toba-II QH of Tehsil Toba Tek Singh remain part of NA-111. So the proposed amendment is just a natural amendment.
- e. The proportion of population of constituencies have not been kept into consideration while making the delimitation. And after the proposed amendment the population of all three NA Constituencies will be more closer to each other i.e. NA-111@ 701223, NA-112 @ 736685 and NA-113 @ 752107 whereas before proposed amendment NA-111 is only 694809 and even below to the figure of seven lac.

**PRAYER:**

In view of above submissions it is respectfully prayed that proposed alteration may kindly be accepted and boundaries of NA-112 and NA-111 may kindly be adjusted as explained above paras of the representation.
