

## BEFORE THE CHIEF ELECTION COMMISSION OF PAKISTAN, ISLAMABAD

## Representation/Objection under section 20&22 of Election Act, 2017 read with Rule 12 of Election Rules 2017.

Respectfully Sheweth:-

- 1. That the applicant is the resident and voter member of District Nankana Sahib and has been contesting elections since 30 years and is interested to contest election from the constituency NA-118, District Nankana Sahib, which is to be held in year 2018.
- 2. That the District Nankana Sahib consists of two general constituencies of National Assembly (NA-117 & 118), NA-117 consists of Tehsil Shah Kot, Sangla Hill, Mohlan QH, Warburton QH, Warburton MC and parts of Nankana Sahib-I QH and NA-118 consists of QH Bara Ghar, QH Mangtanwala, QH Nankana Sahib-II, QH Natha, QH Rehan Wala, QH Syed Wala, Nankana Sahib MC and parts of Nankana Sahib-I QH which are almost equal in population.

- 3. That Warburton QH and Warburton MC has been traditionally part of constituency NA-118 for the last 30 years which has now been included as part of constituency NA-117 and Warburton has no traditional as well as physical administrative and communication link with area of Shah Kot and Sangla Hill which are parts of NA-117.
- 4. That the inclusion of Warburton QH and MC in NA-117 does not make the constituency a compact block. It is merely connected with other parts of the constituency through a narrow belt of one PC namely Chak No.002/GB, which creates the difficulties for the inhabitants of both the constituencies and that parts of Nankana Sahib-I QH and Nankana Sahib-MC if included in NA-117 and Warburton excluded makes the constituency a compact block with physical and communication links.
- 5. That if done so, the population of both NA constituencies of Nankana Sahib District namely NA-117 and NA-118 are almost equal and not having a major difference and as proposed part of the application, the population of NA-117 is 683, 842 and of NA-118 is 672,532.

## PRAYER:-

In view of the submission made above, it is, therefore, most respectfully prayed that Warburton QH and MC may kindly be made part of NA-118 with proposed areas and MC Nankana Sahib and proposed parts of Nankana Sahib-1 QH may also be

included in NA-117, in the best interest of justice, equity and fair-play.

Any other relief which this Honourable Court deems fit and proper may kindly be awarded to the applicant.
