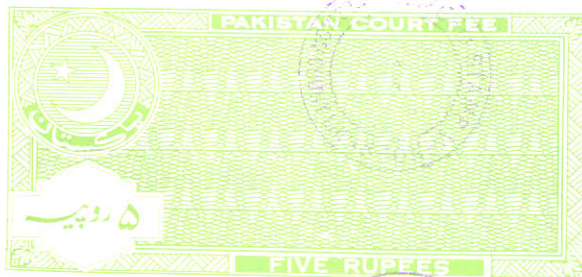

**REPRESENTATION UNDER SECTION 21(3) OF THE ELECTIONS ACT, 2017
READ WITH RULE 12 OF THE ELECTION RULES, 2017 & ALL OTHER
ENABLING PROVISIONS OF LAW FOR NA & PP CONSTITUENCIES FOR
DISTRICT NANKANA SAHIB IN SUPPORT OF THE NOTIFIED PRELIMINARY
LIST ESPECIALLY NA-117 NANKANA-I AND PP-132 NANKANA II**

Respectfully Sheweth:

1. That the Applicant is a citizen of Pakistan and a registered voter bearing CNIC No. 35402-1483843-7, Statistics Block Code: 201070206, Silsila No. 81, Electoral Area: Kot Shah Muhammad, Tehsil and District Nankana Sahib and is verifiable through SMS service 8300 of the Learned Election Commission of Pakistan (the "ECP").
2. That the ECP has notified Preliminary Report regarding Delimitation of Constituencies for the National Assembly and the Provincial Assemblies in Pakistan under Section 21 of the Elections Act, 2017 read with Rule 12 of the Election Rules, 2017. The description of NA & PP Constituencies for District Nankana Sahib with the addition of population against each administrative unit is attached as Annex A and the relevant map indicating the said constituencies is attached as Annex B.
3. That it is conceded by the Applicant that the notified NA & PP constituencies of District Nankana Sahib are completely in accordance with the principles of delimitation enshrined under Section 20 of the Elections Act, 2017 i.e. (i) Fair distribution of population; (ii) Geographically compact area; (iii) Physical Features; (iv) Existing boundaries of administrative units; (v) Facilities of communication; (vi) Public convenience; and (vii) Other cognate factors.
4. The Applicant supports the delimitation of NA and PP constituencies as notified by the learned ECP. However, the Applicant is filing this Representation to reserve the right to respond to other objectors at the time of hearing regarding delimitation of NA and PP constituencies in District Nankana.

In view of the foregoing submissions, it is most respectfully prayed that this representation / objection petition be most graciously accepted and the Preliminary list of Constituencies for NA and PP constituencies be kept intact and notified as final list of constituencies under Section 21(4) of the Elections Act, 2017 read with Rule 14 of the Election Rules, 2017.
