Respectfully Sheweth:-

Facts giving rise to the titled petition are as under;-

1. That petitioner No.1 is a voter in proposed NA-16 in Patwar Circle Pind Kargo Khan Circle Sherwan, whereas, petitioner No.2 is a voter in Canttt. Area village Havelian District Abbottabad.
2. That previously before delimitation of the constituency Abbottabad 1 & Abbottabad 2 were NA-17 & NA-18. Map showing the previous constituency is attached as Annexure "A".
3. That there is no increase or decrease in the National Assemblies Seats.

4. That according to recent report total population of Abbottabad district is 13,23912, previous NA-17 & NA-18 constituencies which were having Geographically, compact areas, physical features, existing boundaries of administrative units, facilities of communication and public convenience and other cognate factors were well according to rules and were in the public interest.

5. That peoples of the locality were also having no objection whatsoever, and there was no need to disturb the previous delimitation, only variation in the population of the constituency can be met by slight modification by joining two Patwar Circles from one constituency to another, proposed constituencies of NA-15 and NA-16 i.e. Abbottabad-I & II are annexed as Annexure "B", while site plan showing preliminary report and list of constituencies specifying the area included in each constituency is annexed as Annexure "C" & "D".

6. That proposed delimitation of the constituencies NA-15 & NA-16 may kindly be modified inter-alia on the following grounds;-

GROUNDS;-

- a) That preliminary report of constituencies NA-15 & NA-16 is not according to rules and law laid down by the apex court of the countries from time to time.
- b) That preliminary report is not based on facts on grounds.
- c) That previous constituency is based on geographically compact block physical features and there are communication facilities in between the areas, and there is also public convenience cognate factors and homogeneity in the constituencies which is lacking in the preliminary

report of newly proposed constituencies.

- d) That proposed constituency NA-15 is totally based on rural area having no education facilities and roads.
- e) That respondent committee has not adopted the uniform policy while making delimitation in the different districts i.e. in District Mansehra no such formula was adopted and similarly in most of the constituencies in the Punjab Province, similarly placed districts were not bifurcated in the similar manner.
- f) That there is no increase and decrease in the constituencies of NA in District Abbottabad, therefore, there was no legal requirement to make delimitation of whole District, except the minor modification to meet the population difference according to law.
