- 6. That to create a balance between NA-167 and NA-168 .QH Gajjiani-2 , PC Chak13 Gajjiani consisting of population 7652 be moved from NA-167 to NA-168 ,

thus making the new population of both the constituencies (NA-167 and NA-168) as follows 1:
