APPEAL AGAINST PRLIMINARY DELIMITATION OF NA-175 & NA-176 ISSUED BY THE DELIMITATION COMMITTEE FOR DISTRIC RAHIM YAR KHAN

espectfully Sheweth:

- 1. That the addresses of the parties are correct to the best knowledge of the petitioner for all kinds of summons and notices.
- 2. That the petitioner is registered voter vide Serial no. 70, Census Block Code No. 250040407, Chak No. 17/ABS, Liaquat Pur Copy of voter list is attached herewith as **Annexure-A**.
- 3. That the Constituencies have been delimited. Moreover, the Election Commission of Pakistan has also issued instructions for delimitation of Constituency under the above enactments by the Delimitation Committee under Rule of the Election Rules, 2017. Copy of preliminary delimitation is attached as Annexure-B
 - 4. That as envisaged in Section-20 of the Gazette of Pakistan, extra, October, 2, 2017, the following principle of delimitation were ignored by the said Committee, which is as follows:

"20 Principles of delimitation.---(1) All constituencies for general seats shall, as far as practicable, be delimited having regard to

the distribution of population in geographically compact areas, physical features, existing boundaries of administrative units, facilities of communication and public convenience and other cognate factors to ensure homogeneity in the creation of constituencies"

- 5. That for the purpose of population of the Constituency within a Provincial Government, it is required to keep it uniform, however, variations upto 10% of either side so as to avoid splitting of Patwar Circle as provided in the instructions ibid is permitted.
- 6. That as envisaged in the instructions of Election Commission, issued for the delimitation of the Provincial and National Constituencies, the said principle has to be observed and for that very purpose, the rural population of District Rahim Yar Khan as mentioned in 2017 District Census Report of Rahim Yar Khan is 48,14,006 and the Delimitation Committee, Punjab has published the delimitation of National Constituencies 06 for District Rahim Yar Khan.
- 7. That the population of Patwar Circle of NA-175 Rahim Yar Khan-I were liable to be included in NA-176 Rahim Yar Khann-II for the purpose of equality of Population, Culture and local language which are as follows:
