REPRESENTATION U/S 21 OF THE ELECTIONS ACT 2017 READ  
WITH RULE 11 OF THE ELECTION RULES 2017 AGAINST  
PRELIMINARY DELIMITATION OF TERRITORIAL CONSTITUENCY  
OF NA-177 RAHIM YAR KHAN-III.

Respectfully Sheweth;

1. That the applicant/objector is a voter member of the constituency of NA-177, Rahim Yar Khan-III. The relevant portion of voter list/certificate of vote from the concerned office is annexed herewith.
2. That the applicant/objector is aggrieved by the preliminary delimitation of territorial constituency of NA-177, Rahim Yar Khan-III (hereinafter to be referred as "impugned delimitation") and seeks its modification inter-alia on the following;

GROUNDS

- i) That the impugned delimitation as published in preliminary report and preliminary list is against the letter and spirit of the law.

- ii) That NA-177, Rahim Yar Khan-III has been delimited in such a way that PCs of 1) Ihsan Pur, 2) Daulat Pur, 3) Abad Pur and 4) Thul Wazir have been included in the impugned delimitation. It is a river side area (Daryai) and has very limited road network and has historically been part of the neighboring constituency of NA-178, so it is to be excluded from the delimitation of the constituency and instead PCs of 1) Butta Kot, 2) Karamabad, 3) Tib Chohan, 4) Aslamabad, 5) Wahi Jumman Shah and 6) Kot Samaba Mohal along with the MC of Kot Samaba are to be included, which are "non-riverine belt" areas. By including these areas in the delimitation of NA-177 Rahim Yar Khan-III, road network and access will be better. Logistical issues may be avoided and there will be better electoral planning for conduct of free and fair election. After including and adding the above PCs and Kot Samaba MC and excluding PCs of 1) Ihsan Pur, 2) Daulat Pur, 3) Abad Pur and 4) Thul Wazir, the population will be meeting the requirement as a proportionate increase to previous constituency of NA-194 Rahim Yar Khan III.
- iii) That the population variance in the proposed delimitation by the Honourable Election Commission is also not adhered to in case of NA-179 Rahim Yar Khan (population 843,794) which is above the prescribed limits of maximum of 10% variance. This suggested proposal also brings the population of the entire district within the prescribed limits as well as spreads the urban, semi urban and rural divide more equitably; NA-179 Rahim Yar Khan-V is having 03 MCs including the district capital of Rahim Yar Khan MC, Tranda Sawai Khan MC and Kot Samaba MC. The entire Kot Samaba Mohal QH except for the PC of Kot Samaba Mohal (population: 1,824) is already with NA-177 Rahim Yar Khan III. The inclusion of this PC as well as the MC of Kot Samaba will help that principles of convenience and compactness are ensured.


