Subject: Objections Over Delimitation of National Assembly Seats NA-211 & NA 212 @ District Naushero Feroze Sindh.

This is in reference to the invitation of the objections under section 21 of Elections Act 2017, read with rule 11 & 12 of the election rules 2017.

District Naushero-Feroze was created in the year 1989, through bi-fercation of District Nawabshah to facilitate Honourable (late) Hakim Ali Zardari sb (father of former President of Pakistan Asif Ali Khan Zardari) on one side & Honourable Ex Prime Minister (late) Ghulam Mustufa Jatoi sb on the other.

Elder generations who respected their neighbors and gave consideration in share of authority and equality to its related areas and local public have left this world and the proper following of footsteps has seen some lapse and gap due materialism and greed of power.

District in the centre of Sindh may have been a business and industrial hub, however there are areas which are on purpose neglected from flourishing and the areas which have always been annexed into two National assembly seats have not served much purpose for the common man and infrastructure. Only low scale textile mills, threading and spinning mills, few food factories cotton ginning, flour mills, ice and biscuit factories, shoe and other cottage industrial factories have existed.

The Taluka boundaries have also been biasedly in favour of ruling elite, with divide and rule policies of original Sindhi Samaat as well as settler Urdu and Punjabi public.

With respect and integrity of all the electoral process, none of administrative boundaries are natural boundaries, either in respect to the River Indus area, Rohri Canal, Railway tracks or National highways.

Two seats of national Assembly in its delimitation have always been in such a way, where Moro and Noshero has been on one side mostly and Kandiaro and Bhiria on the other. There has never been a variety of representation other than the power houses of Darbelo and New Jatoi.

I Mansoor Ali Rajper holding CNIC # 42201 6373908 5 (voter of Deh Chiho block code 341020405, Serial # 996, house 46,) s/o Sardar Khalid Mian Rajpar state that my father was an ex District Management Officer who resigned from his job in 1991 to look after the affairs of his Chieftain responsibilities, Rajpar tribe the single largest tribe in District Naushero Feroze (also the single largest tribe in District Khairpur) to represent them in National politics secured approx 40000/= votes in 1993 on NA 159 NFS 2 in his first election.

To a surprise a candidate who secured approximately 40 thousand votes was not given ticket when the PML-N was ready to come to power in 1997, once again he contested with symbol of PPP in 1997 and till 2:30 am in Courtroom of Naushero feroze, we had a lead of win, and just around 3am, we were declared lost and upon filing the petition at Islamabad, we were "questioned simply why Our petition should not be rejected".

It is pertinent to mention here, that today (1612,373) 16 lacs twelve thousand three hundred & seventy-three people are residing in the District as per census record of 2017, out of which nearly half a million belong to our tribe living in a belt to belt formation naturally since last 200 years with generations of relations among each other. The Syeds and Baluch are a natural rival to this population dividing them into 04 taluka/ tehsils and keeping them suppressed with divide and rule policy of old Britain Raaj. Now as per rules, to elect 02 MNAs from 16 lac people, there should be a variety and choice in representation; if the transparency of election commission may delimit the borders for free and fair unbiased constituencies. Our plea and request for a permanent solution for an opportunity of new faces & an equally balanced feud with norms and due respect to those already enjoying power houses for last 30+ years is to bi-fercate the two seats from North to South of the District with keeping National highway as the border.

One constituency on right side (WEST) of N-5 Motorway and One constituency on the left side (EAST).

PROPOSED: NA 211 from Kotri Kabeer to Moro and down till the end (population 804,306).

PROPOSED: NA 212 from Mehrabpur to Naushero & down till the end (population 808,067).

As the election act gives a 10% relaxation of population in the constituencies, I leave a discretion of any bordering towns to the necessity of ECP to amend closely to national highway without prejudice, my calculation has only a slight difference of 3761 souls. The areas have been carefully without any prejudice proposed for division where all present talukas are represented in both the National seats. (Please note provincial government due pressure & biased approach has never allowed formation of Padidan Tehsil till date).

Being a free citizen of Pakistan, representing to take responsibility of National politics for its betterment and looking at the transparency and integrity, my humble request to the Election commission is to consider the proposal atleast till the next census of 2028 so that a new representation and just purpose of politics may be served for the local people in Assembly atleast for next 4 general elections.
