Representation under section 21 of the Elections Act, 2017, read with rule 12 of the Election Rules, 2017 in respect of the delimitation of constituencies of National Assembly of District Badin

Respectfully Submitted:-

The undersigned applicant submits as under: -

- With reference to Notification No.F.8(3)/2018-Elec-I dated 5th March, whereby this Hon'ble Commission will hear and decide the objections / representations under sub-section (4) of Section 21 of the Elections Act, 2017 in connection with Preliminary list of National and Provincial Assembly Constituencies of Pakistan.
- 2. That a combined reading of section 20 of the Elections Act, 2017 and rule 10 of the Election Rules, 2017 reveals that the following principles and procedures are to be kept in mind at the time of making the delimitation of the constituencies:
 - (i) Distribution of population in geographically compact areas
 - (ii) Physical features
 - (iii) Existing boundaries of administrative units
 - (iv) Facilities of communication
 - (v) Public convenience
 - (vi) Other cognate factors to ensure homogeneity
 - (vii) The delimitation of constituencies of an Assembly shall start from the Northern end of the district; and

- (viii) Then it will proceed clock-wise in zigzag manner keeping in view that population among the constituencies of an Assembly shall remain as close as may be practicable
- (ix) The variation in population between two or more constituencies shall not ordinarily exceed ten percent
- 3. In line with the guidelines provided by law, the Petitioner submits his proposal for National Assembly constituencies namely NA-229 (Badin-I) and NA-230 (Badin-II) in the manner as detailed in the following paragraphs.
- 4. The only difference proposed is the exclusion of one Tapedar Circle (Patwar Circle), namely Khadi Adat of Pangrio STC (QH) of Taluka Tando Bago from NA-229 Badin-I and its inclusion in NA-230 Badin-II. This proposal is made in the interest of maintaining minimum population disparity between the two constituencies of District Badin.
- 5. As per the ECPs proposal, the population of both the constituencies are:

NA-229 Badin-I 922,910

NA-230 Badin-II 881,606

Therefore, a difference of 41,304

6. In case of acceptance of this representation, the population of the constituencies will be

NA-229 Badin-I 904,100 NA-230 Badin-II 900,416

Therefore, a difference of 3,684

7. After acceptance of this representation, the two National Assembly Constituencies of District Badin will be as under

That being aggrieved by and dissatisfied with the part of list of constituencies, published in the Preliminary Delimitation Report, 2018, particularly specifying the areas proposed to be included in / excluded from proposed National Assembly constituencies NA – 229 and NA – 230 of District Badin and in the best interest of the population of the district as a whole, the Petitioner craves the kind indulgence of this Honourable Commission for making amendments, alterations or modifications as suggested / proposed by the Petitioner in paragraphs 4 to 7 above, *inter alia*, on the following

Grounds

- (a) That while preparing the Preliminary Delimitation Report, 2018 comprising of proposals for fresh delimitation of constituencies for National Assembly in Badin District especially proposed NA 229 and NA 230, it is respectfully submitted, the relevant Delimitation Committee failed to adhere to the above stated mandatory principles and procedures in letter and spirit therefore there is a need to revisit the said delimitation proposal by this Honourable Commission.
- (b) By excluding only one Tapedar Circle namely Khadi Adat of Pangrio STC (QH) of Taluka Tando Bago from NA 229 and including the same in NA 230, both the National Assembly constituencies will maintain the minimum disparity of population i.e. <u>3,684</u> only. Therefore ideal constituencies would be created.

In view of the foregoing, it is most respectfully prayed that the instant representation may kindly be accepted and the amendments, alterations or modifications proposed / suggested by the Petitioner in paragraph 4 to 7 of this representation may graciously

be incorporated in the final report and list of constituencies showing the areas included in each constituency.

Any other relief which this Honourable Commission may deem just and appropriate may also be granted to the Petitioner in the interest of law, justice and equity.
