- 1- That the above all Petitioners # 1-9 are resident & voters of **PS-87 / NA-236** and their addresses are mentioned in above title of petition, so they all are fully satisfied by the new **DELIMITATION** of the Constituencies as announced by the Election Commission & endorse it fully with core of hearts & appreciate to the commission for drafting, designing the all constituencies as accordance with nature of distribution of population in geographically compact areas in accordance to the law provided as under **section-9 which is titled with Principles of delimitation.**

- 2- That all of other constituencies PS- 88, PS-89, PS-90, PS-91, & NA-236, NA-238 are deem fit to the accordance of Section-9, i.e. geographically compacted, with their natural boundaries, and these all are homogenously correct except a minor change of single census charge # 05 of Sub Division Ibrahim Hydri which only need to be shuffled with Census Charge # 6 of Sub Division Ibrahim Hydri, remaining nothing else to do a big change / alterations / modifications to the all over other constituencies.

- 3- That further the all boundaries of the administrative units are quite correct and facilities of communication , public convenience are quite 100 % correct, other all voters / residential of PS-87 & NA-236 are quite happy with preliminary proposal by Election Commission, which has no need to alter and modify it upon other petitioners.

- 4- That Census Population Record does not show categorically Wards, Union Councils, Union Committees, Town Committees, Municipal Committees, District Councils etc , except it is categorically described in Census Charges , Circles , Tapedar Circles, STCs , Sub Divisions, Talukas, and District administrations.

- 5- That most of petitioners are trying to get advantages to delimit the constituency as per ward, union council, union committee administrations and Urban / Rural Segregations accordingly, which is not deemed fit, sustainable upon divisions, so for preliminary delimitations of District Malir to be sustained as it is shown is 100% correct.
 - 6- That all of other petitioners are trying to modify the preliminary proposals upon no categorical base except their objections on wards / union council, linguistic differences to get more benefits from it, but it is not as per given law that delimitation will be made upon boundaries of urban / rural difference, wards / UC's differences, so for all other objections are not maintainable to consider for a big alteration, modification in preliminary.
 - 7- That Preliminary proposal of delimitation is most recommendable by all residencies belonging to the district except few elements who want to produce differences upon various grounds.
 - 8- That the honorable commission is requested to consider only its real floats if available i.e. Census Charge # 5 is added in PS-90 without touching boundary to the PS-90, so for solution is only that Census Charge # 5 to be added in PS-91, and Census Charge # 6 to be excluded from PS-91 than to be added in PS-90.
 - 9- That all petitioners who have proposed their own proposal are making a huge difference and will create much grievances in the people who are satisfied from preliminary proposal.

In the view of above, it is therefore prayed that all other petitions for alteration / modifications shall not be considered to alter / modify in preliminary proposal to create and increase much more grievances in the people of District Malir, except the modification & Shuffling of Census Charge # 5 & 6 with each other for PS-90 & PS-91.
