OBJECTIONS ON THE CONSTITUENCIES OF P.S 110 AND P.S 111 OF DISTRICT SOUTH KARACHI.

- 1. P.S 110 District South Karachi consisting of a total population 374,132.
- 2. P.S 111 District South Karachi consisting of a total population 358,220.
- Charge No. 4 of Sub-Division Civil Lines consisting of 58749 population of District South has been illegally broken included in Sub-Division Clifton Cantonment of P.S 111.
- 4. Entire Karachi Cantonment consisting of 68877 population is illegally merged into P.S 110, though cantonments deals with all the affairs of the basic facilities and development scheme of the area itself.
- 5. That Geographic and compactness of both the Constituencies have affected. The authorities have not taken into consideration the following section of the law, before delimiting the constituency of P.S 110 and P.S 111, such as;

Anglon 3

Section 20 of the Election Act 2017, provides that (1) All constituency for general seats shall, as far as practicable, be delimited having regard to the distribution of the population in geographically compact areas physical features, existing boundaries of administrative units, facilities of communication and public convenience and other cognate factors to ensure homogeneity in the creation of constituencies.

- (2) For the purpose of delimiting constituencies for the general seats of the National Assembly for the Tribal Areas two or more separate areas may be grouped into one constituency.
- (3) As far as possible, variation in population of constituencies of an Assembly or a local government shall not ordinarily exceed ten percent.
- (4) If the limit of ten percent under sub-section (3) is exceeded in an exceptional case, the Commission shall record reasons thereof in the delimitation order.
- 6. That Ward No. 4 of Union Committee No.30 (consisting of 4 wards) and Ward No. 4 of Union Committee No.31 (consisting of 4 wards) have been illegally broken and detached from both the U.Cs
- 7. That Infrastructure of the Charge No.4 shall badly affect in case of the delimitation of the constituency. Civil facilities like Water, Sewerage, Sanitation and Development which are the responsibility of KMC but by this delimitation the said facilities shall be frustrated and the people would face great deal of difficulties. The convenience of the people and their basic facilities have not been taken care of by the ECP / Delimitation Authorities.
- 8. The areas of Karachi Cantonment and Clifton Cantonment would not change by the exclusion of the Charge No.4, rather the area

- 9. The population of Charge No. 4 consisting of sub-division Civil lines 58,749 U.C 30 & U.C 31 Ward No. 4 of both the U.Cs may be included in the P.S 110 and excluded from P.S 111. The portion of the Karachi Cantonment having population of 68,877 may be included in the P.S 111 and excluded from P.S 110.
- 10. That after excluding the part of Karachi Cantonment from P.S 111 and including Charge No. 4 into P.S 110 no any effect would made on both the constituencies of P.S 110 and P.S 111.
- 11. That while conducting census the population of the both the cantonment areas were separately counted while the civil part was separately counted.
- 12. That Even on the basis of the above proposed amendments only minor changes are proposed which would not only save irrational distribution but so also shall make the constituencies compact without changing their geographical status.
- 13. That this will meet with the ends of justice if your honour may be pleased to consider the representation / objections and allows the proposals made by the applicants.
