I was elected as Member of National Assembly of Pakistan from Baluchistan Province Constituency No NA-265 (Sibbi, Harnai, Dera Bugti Cum Kohlu) during the General Election for the year 2013. Therefore I am also an existing Member of National Assembly on the above noted constituency.

Furthermore, it is submitted for the Kind notice of worthy Election Commission of Pakistan the proposal Draft List of Constituencies of National Assembly for completion of delimitation process has been displayed on the 5<sup>th</sup> instant for the purpose about submission of objections on the subject Draft List of Constituencies.

4. In addition it is also brought to the information of Hon'able Commission that from the perusal of newly Draft List of Constituencies of National Assembly relating to Baluchistan Province it reveals that NA-259 has been proposed on the following five Districts (Units) :-

On the other Hand due to Geographical as well as Language Relation, it is very necessary the disputed District Barkhan may remain with NA-258 (Loralai, Musa Khail, Ziarat, Dukki Cum Harnai) in the best interest of General Public of the area. 
