1. That the objector is a local permanent resident of Gwadar District & serving the people of Gwadar as elected Chairman District Council since 2013. As well as also served as District Nazim Gwadar during 2001 to 2005 as well.  
That Tahira Khurshid working as a Political activist of Gwadar and Balochistan
2. That on 07.Mar.2018 objector/appellant got information about notification of delimitation for constituencies whereby the respondent annexed the territory of Gwadar District with the limits

3. That the objection being aggrieved from the notification and filed the objection of the on the following amongst grounds"

Grounds

- A. That the objector/appellant as well as inhabitant of the locality have been deprived of their fundamental right, which is being denied in the notification as the Gwadar is within the limits of Kech District and without any plausible reason and justification issued such notification.
- B. That it is important to mention to here that historically Gwadar is a part of Makran Division, which comprises of three(3) Districts,

Which are as follows:-

- i) Gwadar
- ii) Kech
- iii) Panjgoor

As turbat is the Divisional Headquarter of Makran. The Divisional Headquarter is situated 150KM away from Gwadar, while the Lasbella is situated more than 600 Kms away from District Headquarter Gwadar

- C. That the main source of sweet water of Gwadar is Mirani Dam Kech. The inhabitants of Gwadar are sharing Educational facilities with Kech District because all colleges of Gwadar District are affiliated with Turbat University and also Sub-Campus of Turbat University is functioning here at Gwadar.
- D. That the main electric transmission line of Gwadar is also being from control from Kech District
- E. That it is imperative to mention here that the language used all over the makran is Balochi, while the majority of Lasbella people spoke lasi language.
- F. That the people of Gwadar have a stronger bound with the people of Kech & panjgoor in terms of economy, language, Culture, Politics, Life style, mindset & even the distance with people of District lasbella
- G. The fresh delimitation of constituency may have dire implication & consequences upon the development of Gwadar Port & working on CPEC.
- H. The Keeping in view the best interest of Gwadar District, following amendments are being proposed to protect the rights & interest of people of Gwadar.
