**REPRESENTATION UNDER SECTION 21 (3) OF ELECTION ACT 2017
REGARDING NA 53 ISLAMABAD**

1. That the petitioner is a resident of union council Pind Bagwal bearing CNIC 61101-1830878-9 having Block code no. 501010701, Silsilla No. 427, polling area Maira Bagwal falling in NA 52 which is segmented and bifurcated without adopting principal of compact and clock wise inclusion of petitioners resident area and deliberately placed in NA 52.
2. That the federal territory of Islamabad have been divided into three constituencies named NA 52 NA 53 and NA 54. The total population of NA 52 is 700744, population of NA 53 is 670683 and population of NA 54 is 630152.
3. That the senses charge of federal capital bearing charge no 6 comprising up of sector F 6, F7, E6, E7 and said pour village etc. are dimensionally not following within constituency of NA 53 but due to ulterior motives charge no 6 was cut down and attached/pasted in NA 53 whereas it part and parcel of NA 54.


4. That a large no of population is directly affected by this uneven distribution and division of charge 6 instead of including the local population of Pind Bagwal, Gumrah Khas, Maira Begwal etc along with other necessary areas of union council Pind Begwal have not been included in NA 53 deliberately which is already horizontally and vertically falling within the constituency of NA 53.

5. That while dividing the Federal Capital Territory in three constituencies the basic principles of census and division has not been followed and ethnic rules of division have not been applied resulting in unjust, unfair and meritless distribution of population of union councils and out of same union councils different revenue estates are annexed and attached with different constituencies which shall amount to gather a reference of pre pole rigging .

6. That in order to avoid above mentioned complexities the proposed replacement of charge 06 with Maira Begwal etc may kindly be act upon so that the nomenclature and shape of the constituencies be clear and in this way unfair scattering of union councils can be settled down.

IN THESE CIRCUMSTANCES REFERENCE IN HAND MAY KINDLY BE ACCEPTED AND CHARGE 06 OF NA 53 MAY KINDLY BE OMITTED FROM NA 53 AND LOCAL AREAS OF MARA BEGWAL, GUMRAH KHAS, PIND BEGWAL ETC ATTACHED WITH NA 52 MAY KINDLY BE OMITTED AND ATTACHED THEM WITH ALL OTHER AREAS OF UNION COUNCIL IN NA 53 IN THE LARGER INTEREST OF JUSTICE AND PUBLIC AT LARGE OF APPLICANTS AREA.
