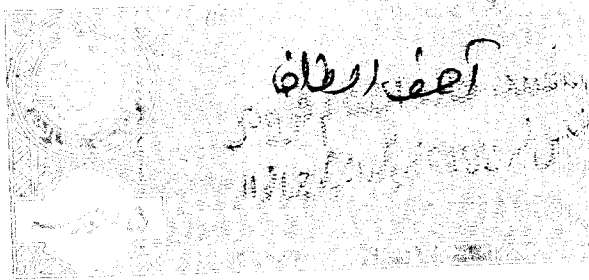

3. That the delimitation of NA 81 Gujranwala-III has been proposed against the principle of delimitation as given

in the Election Act 2017 and the Rules made thereunder
in as much as

- (a) NA 81 Gujranwala-III mainly consists of urban area of Gujranwala City whereas charge No. 12 included in this Constituency consists of village Aroop, Wanyewala, Chak Khizar, Songowale, Abdal, Kotli Adu and Lohinwala. These villages have no urban character but have been illegally delimited in the urban area of Gujranwala City.
- (b) That M.C Ladhaywala Warriach was urban area and quite contiguous to charge No. 32, 33, and 34 of MC. Gujranwala but it has been delimited in NA. 80 and not in this Constituency.
- (c) Q.H. City Gujranwala-II has not been included in any Constituency of District Gujranwala. It is a flagrant violation of delimitation.
- (d) That the shape of NA-81 Gujranwala-III is irregular and is not compact. This is violation of the delimitation rules.

- (e) That the total population of this Constituency as given in the proposal is not correct.
- (f) That the area of this Constituency falls in 5 police stations of District Gujranwala and as such it would not be convenient for the administrative purposes.

It is therefore, respectfully prayed that charge No. 12 of Municipal Corporation Gujranwala except Circle No.8 may be included in NA.80 Gujranwala-II and may be excluded from NA. 80 Gujranwala-III and Municipality Committee Ladhaywala Warriach may be excluded from Constituency NA 80 Gujranwala-II and may be included in NA-81 Gujranwala-III.
