REPRESENTATION under Section 21 of the Election Act 2017 read with Election Rule 12 of the Election Rules 2017.

The petitioner represents as under:-

1. The Election Commission of Pakistan, Islamabad has delimited Constituency No. 80 Gujranwala-II and 81 Gujranwala-III vide its notification dated 5th of March, 2018.
2. That the objector is a registered voter in Talwandi Rahwali of District Gujranwala and objects to the

delimitation of NA 80 Gujranwala-II and NA 81
Gujranwala-III as under:-

- (a) That NA 80 Gujranwala-II and NA-81 Gujranwala-III have not been delimited according to the principles of delimitation as mentioned in Election Act 2017 and the Rules made thereunder in 2017.
- (b) That Municipal Committee Ladhewala Warriach has not nexus with Gujranwala Cantt. or Q.H. Talwandi Rahwali but it has been illegally included in NA. 80.
- (c) That Q.H. Talwandi Rahwali has been bifurcated and a part of it has been attached in NA.80 while another part consisting of villages Aroop, Abdal, Sangowali, Wanyewala and Chak Khizar have been included in NA. 81. This is against the principles of delimitation.
- (d) That in N.A.80 parts of police stations Ladhewala Warriach, Qilla Dedar Singh, Gujreanwala Cantt. and Aroop have been included. To include the areas of four police stations in one Constituency will not be administratively feasible.

- (c) That Municipal Committee Ladhewala Warriach is quite contiguous to charges No. 34, 35 and 36 which have been included in NA. 81 and, therefore, M.C Ladhewala Warriach should be included in NA. 81.
- (f) That circle No. 7 of charge 12 of M.C Gujranwala (Village Aroop), is quite contiguous to NA.80 but has illegally been included in NA. 81.
- (g) Q.H. Gujranwala City-II has not been included in any of the Constituency of Gujranwala District.

It is, therefore, humbly prayed that Municipal Committee Ladhewala Warriach may be included in NA.81 Gujranwala-III and Circle No. 7 of charge No.12 of M.C Gujranwala may be included in NA.80 Gujranwala-II.
