✓ It is requested that the undersigned is registered as a voter at serial No. **32** Block Code: **175020303** village **Jholana** District **M.B. Din**. The preliminary proposals of Constituencies of National Assembly of District M.B. Din are against the principle of Delimitation prescribed in the Election Act, 2017. The preliminary proposals are not geographically compact areas. The facilities of communication and public convince and other cognate factor to ensure homogeneity has not been ensured in the preliminary proposals.

The following proposals fulfill the criteria of Delimitation of constituencies of National Assembly as prescribed in the Election Act, 2017.

- (a) M.B. Din Tehsil (including Mangat TC Old) excluding the following QHS
- 1- Kathiala Sheikhan
  - 2- Sohawa except the following Patwar Circle
- (i) Jholana
- (b) Phalia Tehsil excluding the following QHS
- 1- Qadirabad except the following Patwar Circle: (i)- Seeray
  - 2- Bherowal and
  - 3- Qadirabad TC (Old) of Mandi Bahauddin District
- Total Population = **793731**

NA-86 M.B. Din-II

- (a) The following QHS of M.B. Din Tehsil
- 1- Kathiala Sheikhan
  - 2- Sohawa except the following Patwar Circle
- (i) Jholana
- (b) The following QHS of Phalia Tehsil
- 1- Qadirabad except the following Patwar Circle (i) Seeray
  - 2- Bherowal and
  - 3- Qadirabad TC (Old) and
- (c) Malakwal Tehsil of Mandi Bahauddin District.

**Total Population = 799561**

In this representation there is change of only three Patwar Circles of Tehsil M.B. Din and one Patwar Circle of Tehsil Phalia. The Patwar Circle Jholana will be excluded from preliminary proposal of NA-86 and will be included in NA-85. Furthermore Patwar Circles Sohawa Bolani and Sohawa Jamlani will be excluded from preliminary proposal of NA-85 and will be included in NA-86. Patwar Circle Seeray of Tehsil Phalia will be excluded from NA-86 and will be included in NA-85. In this way the difference of Population between NA-85 and NA-86 will remain only 5830. The remaining preliminary proposal will remain intact. The representation may be accepted please.
