SUBJECT: PRESENTATION UNDER RULE-12 OF THE
ELECTION RULES 2017 (THE RULES)
READ WITH SECTION 20 OF THE
ELECTION ACT-2017 CHALLENGING THE
PRELIMINARY PROPOSAL PERTAINING TO
THE DELIMITATION OF NATIONAL
ASSEMBLY SARGODHA N.A.88 to N.A. 92

Respected Sir,

1. The instant representation is being filed by Malik Nazir Ahmed Sobhi hereinafter referred to as Applicant Voter Number -116 of N.A.91. The applicant is duly competent to file the instant representation under the Law.
2. Through this representation the applicant seeks to challenge preliminary delimitation proposal published by the Election Commission of Pakistan (Hereinafter referred ECP), pertaining to the delimitation of N.A.88 Constituency Sargodha -I. Hereinafter referred as preliminary proposal which was provided by the Election Commission of Pakistan, as attached Annexure-A.
3. It is pertinent to mention here that in the preliminary proposal vide Notification No.F.8(3)-2018-ELC-1 District Sargodha total area of square kilometers.

4. Followings are objections on delimitation of N.A.88 Sargodha-I Constituency:

- a. That according to old delimitation plan the first N.A. Constituency was started from Tehsil Shahpur as Sargodha-I N.A 64, keeping in view northern end of the District, whereas in new delimitation plan N.A.88 (Sargodha-I) Constituency started from Tehsil Bhera and wrongly taken Bhera as Northern end of District Sargodha which is against the law of delimitation.
- b. The phularwan (T.C) is located in Tehsil Bhalwal which comes in N.A.88 Sargodha-I (according to new delimitation plan), and Phularwan (T.C.) itself designated to PP.73 Sargodha-2, but whole Phularwan (T.C) is allotted and surrounded by PP-72 Sargodha-I which is against the spirit of law of compactness.
- c. That according to new delimitation plan ECP has given geographical area of three Tehsils to one constituency that is N.A-88 Sargodha-I which is against the Law.

SUGGESTED AMENDMENTS IN THE PRELIMINARY PROPOSAL:

1. N.A-88 Sargodha-I shall be consisted of Tehsil Bhera taken as Northern end of District Sargodha + Tehsil Shahpur and to complete the quota of population small portion of Bhalwal which is adjoining to Bhera shall be made a compact constituency which fulfills the principal of delimitation as mentioned in the delimitations of constituencies Act.
2. N.A-89 Sargodha-2 will consist of remaining major portion of Bhalwal and complete tehsil Kot Momen.

3. That Tehsil Sargodha is the largest Tehsil in the District and population of Tehsil Sargodha is more than two N.As. constituencies. Therefore Tehsil Sargodha shall be consisted of two N.As Constituencies and extra portion of Tehsil Sargodha shall be attached to next adjoining constituencies that is N.A.90 Sargodha-3 which is consisted of Rural Areas as mentioned in Annexure.....

N.A 91 Sargodha-4 shall be consisted of whole city.

4. That N.A 92 shall be included complete Tehsil Sillanwali + Tehsil Sahiwal + Extra left over small rural portion of Tehsil Sargodha which is adjoining with N.A. 92 Sargodha-5. Annexure.....

Keeping in view above mentioned suggestions all 5 constituencies of Sargodha shall be allotted two tehsils to one N.A. Constituency. I have suggested the delimitation plan keeping in view the principles of the delimitation in the Act. It is further noticed that a new delimitation plan has been made either malafidely or have not considered the principles of delimitation. I hereby declare that the suggested delimitation plan is made keeping in view Public interest at large. The most advantage in this suggested delimitation plan is that each MPA will be allotted one Tehsil. According to suggested plan one MPA at one Tehsil fulfill the aim and objective of principles of delimitation having regard to the distribution of population in geographical compact areas, existing boundaries of administrative units, facilitates of communication and public convenience and other cognate factors.
