**REPRESENTATION UNDER SECTION 21(2) OF ELECTION ACT, 2017 READ
WITH RULE 12 OF ELECTION RULE, 2017 AGAINST PRELIMINARY REPORT,
SUBMITTED BY DELIMITATION COMMITTEE, REGARDING (CONSTITUENCY
NO. NA-93, DISTRICT KHUSHAB-I) IN THE PROVINCE OF PUNJAB**

Respectfully Sheweth:-

1. That the Petitioner CNIC No. 38201-8220447-3 Namely Imtiaz Saleem Shakir, attached at **Annexure-A** is a registered voter in present (Constituency No. NA-69, Khushab-I) and his name appears in the Electoral List, pertaining to the Electoral Mohalla Mitha Tiwana, Silsala No. 60, Gharana No. 20, Circle No. 3, Tehsil & District Khushab. The extract of the Electoral List of the area is attached herewith as **Annexure- B**, for ready reference.
2. Brief history of District Khushab is that headquarter of District is at Jauharabad and physical feature of Khushab in length of District from North to South is about 116 Kilometers while its breadth from East to West is 56 Kilometers. The District comprises on an area of 1627688 acres or 6511 square Kilometers. District Khushab is a region of complex topography. It consists of mountains, plains and sandy dunes and divided in four major physical Divisions:
 - i) The Salt Range or Soon Valley.
 - ii) Piedmont or the Mohar.
 - iii) The Thal Desert.
 - iv) The Jhelum Valley

3. Khushab District having population 12,81299, and is consisting on four Tehsils Namely:

1.	Khushab Tehsil	=	689742 Population
2.	Naushera Tehsil	=	117942 Population
3.	Quaidabad Tehsil	=	230320 Population
4.	Noorpur Thal Tehsil	=	243295 Population

4. According to the draft population 2017, the quota of seats in District Khushab is as under:-

National Assembly Constituency = 1.64
Provincial Assembly Constituency = 3.46

and the average in Pakistan per seat of National Assembly population in Pakistan is 780266/- and average in Punjab Province the average of population is 370429/- population.

5. During the delimitation of constituency for conduct of General Election-2018, under section 21 to 22 of Electoral Roll Act, 2017 and rule 10 to 14, Khushab District have been demarcated in 2 National (NA-93 Khushab-I & NA-94 Khushab-II as well as in 3 Provincial (PP-82-Khushab-I, PP-83 Khushab-II and PP-84 Khushab-III seats.
