Subject: **REPRESENTATION.**

It is respectfully submitted;

- 1. That the petitioner /applicant is permanent resident of Manjohti of Sohbatpur and is also a registered voter of the same area. The area of Sohbatpur prior to 2013 was part of Jaffarabad District however, now the same has been given the status of District. The area of Manjohti falls under the patwar circle of Muhammadalipur which is a very vast circle consisting upon many areas of Sohbatpur. Unfortunately when the District Sohbatpur was created area of Manjohti with malafide intentions by the concerned authorities was not included in the same.
- 2. That in the year 2017 census were carried out in the area and in consequence thereof the new election constituencies were created. The District Sohbatpur was included in the constituency Jaffarabad cum Sohbatpur however, the area of Manjohti was not included in the same. Despite the fact that the people of the area belongs to Sohbatpur all their affairs are concerned with the same

District even the patwar circle for the revenue purpose is also the same and left remained in Jaffarabad.

3. That now the area of Manjohti is being controlled and regulated from Dera Allah Yar which is the District Headquarter Jaffarabad and is far flung from the same which is causing prejudice to the area as well and they are facing difficulties in resolution of their problems. Now in new delimitation for the constituencies for the General Election again people of the area facing hardship as area of Manjohti has been included in Jaffarabad constituency. The instant is Petition is being filed for correction of the delimitation of the constituency.

GROUNDS:

A. That the delimitation of new constituency of Jaffarabad including the area of Manjohti is incorrect as the boundaries of Manjohti did not connect with the area of Jaffarabad and there are many other areas / union council are in existence in between Jaffarabad and Manjohti hence, the delimitation is liable to be revised and the area of Manjohti be excluded from Jaffarabad.

B. That inclusion of Manjohti area in Jaffarabad is contrary to the principles, rules and Election Laws and the same area is liable to be included in Sohbatpur District consistency.

- C. That the delimitation of the petitioner's constituency i.e Jaffarabad the concerned authorities did not take into count the principles laid down under the law for the same and failed to apply prudent mind in this behalf hence, the delimitation is liable to be reconsidered and the area of Manjohti be excluded from Jaffarabad constituency.
- D. That the Petitioner reserves his rights to urge any other ground at the time of hearing of the Petition.

It is therefore prayed in the light of above submissions that delimitation of constituency Jaffarabad may be revised and the area of Manjohti may be excluded from the same in the interest of justice.
