Respectfully Sheweth;

1. That, the petitioner is registered voter in Constituency PB-30 Quetta-VI with Census Block Code # 451110605 and the name of the petitioner is at serial No.48, Municipal Corporation, Quetta and in pursuance of Notification No.F8(3)/2018-Elec-I dated 05th March, 2018 the petitioner's constituency has been changed.
2. That, the petitioner is aggrieved by the new delimitation of the

Constituency on the following inter-alia grounds:-

A. That, the new delimitation as published in preliminary report and preliminary list is against the provisions of section 20 of the Election Act, 2017 read with rule 10(4) & (5) of the Election Rules, 2017 and it is also observed that the preliminary above constituency has been constituted against the above provision of Rules and Act of 2017 because it was the principle laid down under the rules and act, the constituency will be started from northern side of the District and zigzag manner keeping in view these principle has not been applied, which is against the Rules and Act of 2017.

B. That, the total population of the Preliminary constituency is 272179 which runs north to south with long distance which has no geographically compact and also physical feature in which the units of administrative

boundaries have been affected, which is also against the Rules and regulation and the same is against the ingredients of Section 20 of the Election Act, 2017, which is not accessible nor approachable to the representative of the area, therefore the consideration cannot be possible in the eyes of public interest.

- C. That, it was also observed by the National and International news agencies likewise the real fact of the delimitation was drawn in the Dawn Newspaper in its issue dated 20-03-2018 with the title of "Delimitation Paradox" inequality is a direct outcome of the law itself that has set the principles of delimitation written by Tahir Mehdi, it means independently observed the preliminary delimitations of Election Commission of Pakistan of the Constituencies overall Provinces of the country, therefore, the same needs consideration.



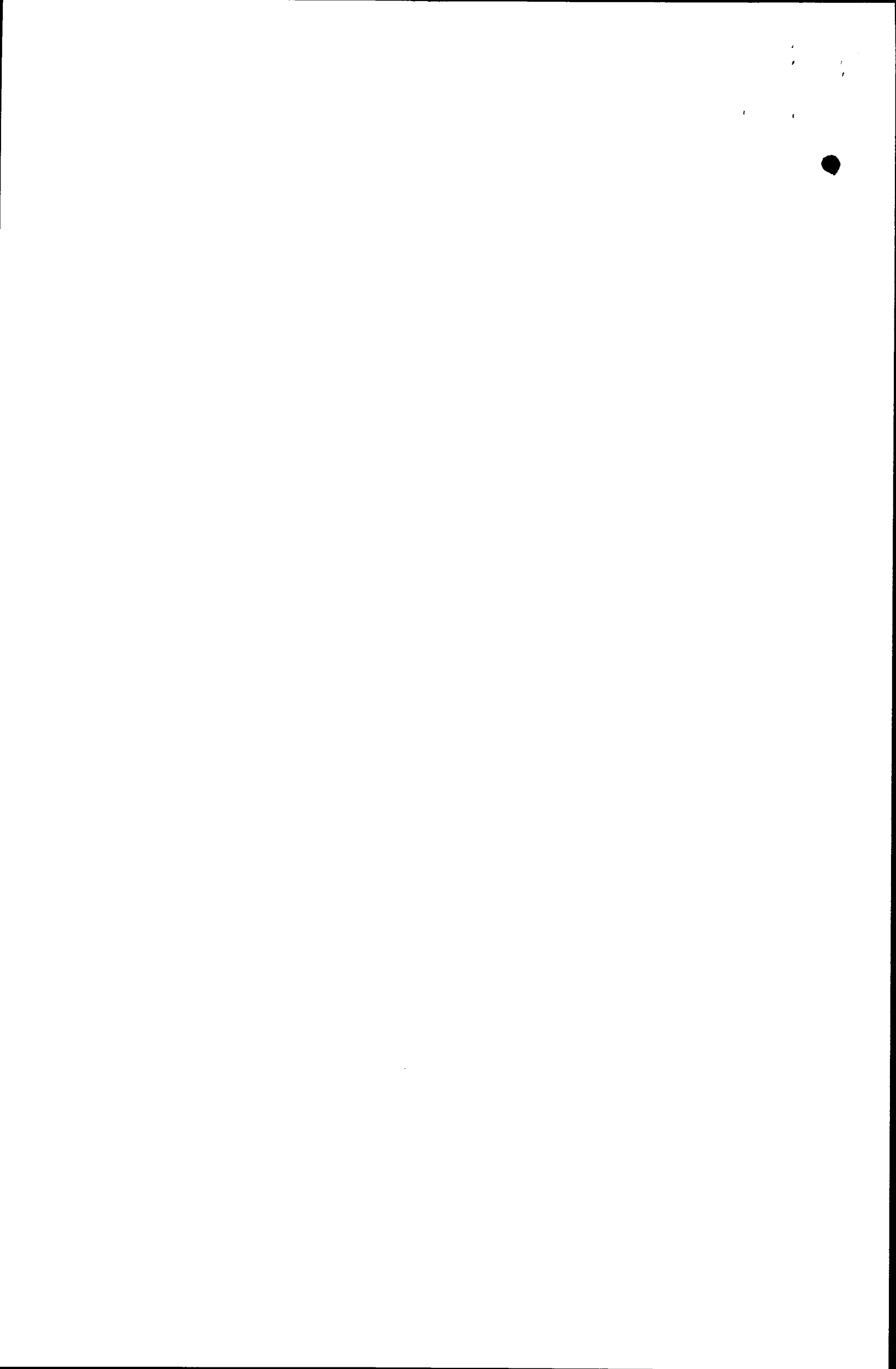

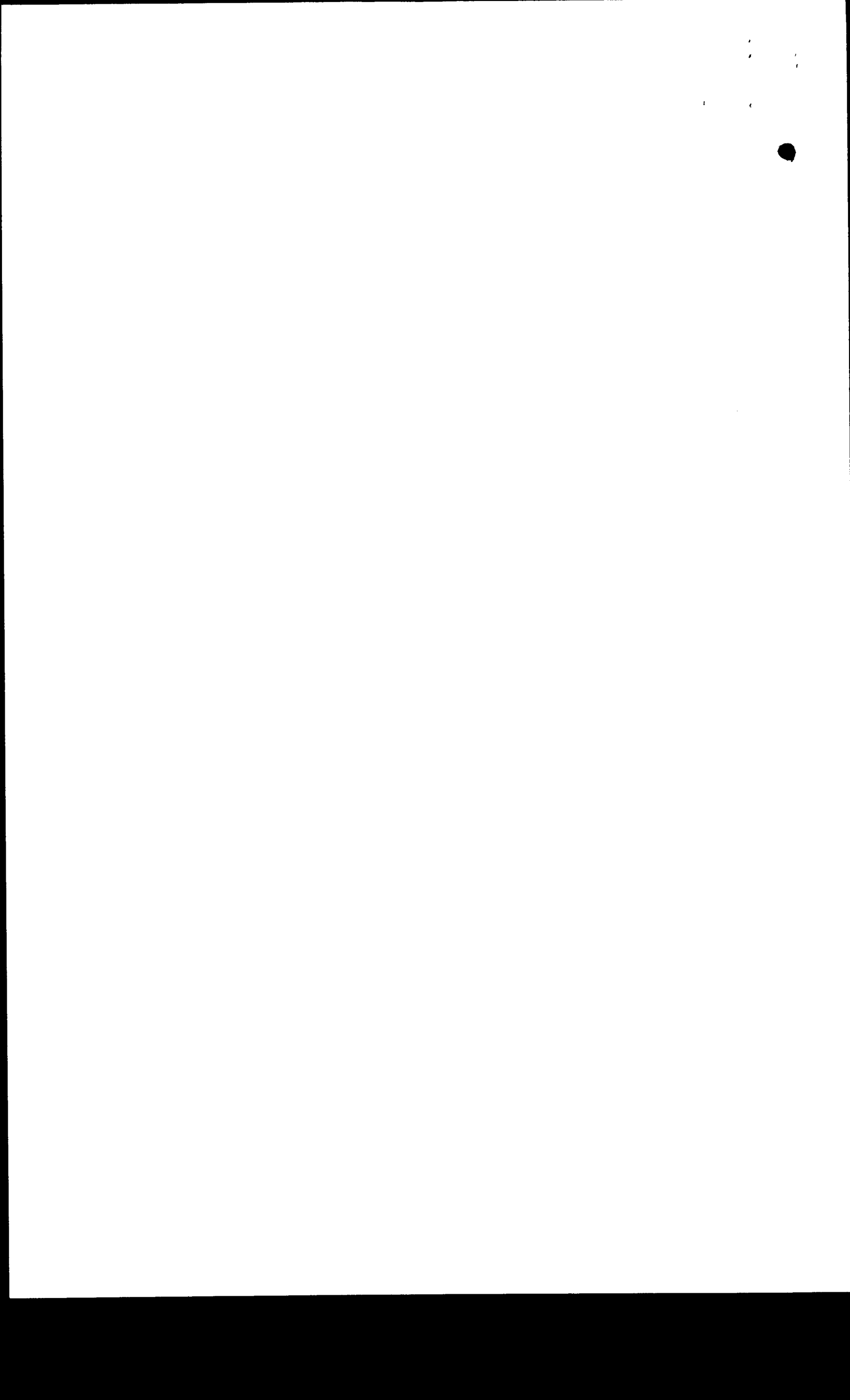


