GROUNDS:

- A. That Buleda and Zamrun is a remote and border area with different mind set and psychology.
- B. That there is very long distance it will solve the distance Problem.
- C. That people have travel to Turbat from Buleda which is very long and difficult distance.
- D. That Pidrak should be restored to his previous position and be merged with Turbat City (PB-46).
- E. That in existing delimitations constituency of PB-45 Kech-I there is a scattered population and typical geographical situations between Sub Tehsil Buleda and Sub Tehsil Zamrun and other remaining constituencies so the means of communication are very poor. Hence keeping in view convenience of the people, cognate factors and homogeneity of the inhabitants of this constituency. Therefore, the Sub Tehsil Buleda and Zamrun be excluded from PB-45 and be included in PB-48 due to the reason stated above.
- F. That right from Nasirabad upto Dandar, they lay in one sub-Division, and one Tehsil.
- G. From the last 30 years, Aamuran and Bulida are the main banificary and the rest of areas have been ignored by the representative their netric develop against the representative of area.
- H. That the people are very much poor, and the people of Bulida and Zamuran are hidely Militant and the use always threat people of this remate areas.
- I. That two sitting MPA's of this are (Bulido, Zamuran) have been killed by their own turles has been hit by unknown and a candidate of this area Ghulam jan Baloch has been killed, by their enimity. So its very much impossible for the people of sami Shahrale other area of counstury to run the election campaign in Bulida and Zamuran.
- J. That 1/3 voters are from Bulida and Zamuran and 1/3 are from remaining areas.
- K. That the distribution of population in geographically compact areas, physical features, existing boundaries of administrative units, facilities of communication of and other cognate factors of Buleda Sub Tehsil and Zamrun Sub Tehsil are completely insured homogeneity with the population of the constituency of PB-48. Hence these 02 Sub Tehsil under the law should be excluded from PB-45 and included in PB-48.

L. That similarly distribution of population in geographically compact areas, physical features, existing boundaries of administrative units, facilities of communication of and other cognate factors of Pidrak UC are completely insured homogeneity with the population of the constituency of PB-46. Hence this UC under the law should be excluded from PB-45 and included in PB-46.

Prayers:

In above sitation it is humbly prayed the present position of PB-45 Kech-I, PB-46 Kech-II and PB-48 Kech-IV be changed by excluding the Buledha Sub Tehsil and Zamrun Sub Tehsil from PB-45 to include the same in PB-48 and Pidrak UC may be excluded from PB-45 and be included in PB-46.

Any other relief deem fit and appropriate may also be granted by considering distribution of population in geographically compact area, physical features, existing boundaries of administrative units, facilities of communication and public convenience and other cognate factors of ensure homogeneity in the creation of constituencies.
