Subject: OBJECTION TO DELIMITATION WHEREBY
BOSTAN SUB TEHSIL HAS BEEN REMOVED
FROM EX-PB-8 PISHIN AND MERGED INTO PB-
19 PISHIN-I

The applicant Nizamuddin son of Abdul Habib,
CNIC No. 54302-0775603-5, resident of Killi Mughtian, Tehsil
Bostan, District Pishin, respectfully submits objections on
delimitation as under:

1. That the applicant is a patriot citizen of Pakistan
and permanent resident of Killi Mughtian, Tehsil Bostan and
further belongs to political party known as Awami National
Party (ANP). Further, the applicant had also contested general
election of Provincial Assembly from previous constituency PB-
8 Pishin on the ticket of ANP.

2. That now after delimitation and creation of new PB-
19 Pishin-I, the above said Tehsil Bostan has been removed
from the above mentioned area and has been merged into PB-
19 Pishin-I, as follows:

- a) Barshore Sub Tehsil,
- b) Karezat Tehsil,
- c) Bostan Tehsil, and
- d) Nana Sahib Tehsil of Pishin District.

3. That the area of Tehsil Bostan is adjacent to the
area of newly created PB-20 Pishin-II, whereas it is far-flung
from the area of PB-19 Pishin-I. It is also pertinent to mention
here that PB-19 Pishin-I and PB-20 Pishin-II are mountain

areas and in case Tehsil Bostan is not removed from PB-19 Pishin-I and not merged into PB-20 Pishin-II it would be inconvenience and very expensive for the applicant and other candidates to contest the election from PB-19 Pishin-I, as Tehsil Bostan, Tehsil Karezat, and Tehsil Barshore are at a distance of more than 250 kilometer, whereas Tehsil Bostan is adjacent to the areas of PB-20 Pishin-II, as such it is rational and logical that Tehsil Bostan be merged into PB-20 Pishin-II, whereas area of Manzaki Patwar presently existing in PB-20 Pishin is closer to other area of PB-19 Pishin-I, as such same is required to be removed from PB-20 Pishin-II and merged into PB-19 Pishin-I and Tehsil Bostan is required to be removed from PB-19 Pishin-I and merged into PB-20 Pishin-II. Copies of relevant documents are enclosed herewith.

It is, therefore, prayed that Tehsil Bostan may kindly be removed from PB-19 Pishin-I and merged into PB-20 Pishin-II and area of Manzaki Patwari be removed from PB-20 Pishin-II and merged into PB-19 Pishin-I and also population of both the area would be as per policy of Election Commission, in the interest of justice, equity and fairplay.
