NECESSARY AMENDMENT / ALTERATION /
MODIFICATION FROM THE LIST OF CONSTITUENCY
FOR THE PURPOSE OF DE-LIMITING
CONSTITUENCY.

*The humble petitioner (Nawabzada Mir Zafarullah Khan Zehri
son of Nawab Sardar Doda Khan Zehri) respectfully submits as under:*

1. *That the petitioner is voter in the constituency belonging to
District Shaheed Sikandar Abad.*
2. *That petitioner presently is elected Member of Provincial
Assembly from PB-37 Kalat-II.*
3. *That representation is submitted within the stipulated period
of 30 days.*
4. *That new district namely Shaheed Sikandar Abad created
by virtue of Notification No. 103-A-13 dated 17.07.2017 by*

Government of Balochistan Revenue Department with the territorial limits of existing Sub division Sohrab.

5. That prior to creation of this new district Sub Division Sohrab was part of district Kalat.
6. That it is pertinent to mention here that at the time of creation of new district Union Council Dasht-e-Goran was not part and parcel of Sub Division Surab.
7. That with malafide intention of certain interested persons and reasons known to certain quarters union council Dasht-e-Goran included in Sub Division Suab by virtue of Notification dated 08.09.2017 which reads as follows:

NOTIFICATION

No. 103 A 13/2060-86. In exercise of powers conferred under Section 6 of the Balochistan Land Revenue Act, 1967 (XVII of 1967), the Government of Balochistan is pleased to exclude the area of "Dasht-e-Goran" comprising of seventeen (17) mouzas and three mouzas of Baincha namely mouza Surmassang, Dat and Muhamamdzai form Tehsil Kalat District Kalat and include the Samein Tehsil Surab District Shaheed Sikandarabd in the interest of public service with immediate effect and until further orders.

8. That there is serious dispute between two tribes of Mengal and Zehri which is main cause of inclusion of above said

Area of Dasht-e-Goran and Baincha and the same is malafide and bad intention on the part of interested persons, if it remain so and not excluded for the purpose of election it will create dire consequences God forbid.

9. *That during Census period of Dasht-e-Goran fell in district Kalat wherein three Mouzas namely Surmasang, Dat and Muhammazai have been excluded from Kalat and included in district Shaheed Sikandarabad.*
10. *That total population of Tehsil Dasth-e-Goran is 25461 out of which population of 8146 has been taken out from the said Tehsil and included in district Shaheed Sikandarabad (which is population of district Kalat), this is serious allegation and bad intention on the part of the administration and certain interested persons.*
11. *That moreover the principle of Section 20 of the Act 2017; have also not been followed; such as:*
 - (i) *Distribution of population in geographically compact area as is indicated from the map attached;*
 - (ii) *Physical feature*
 - (iii) *Existing boundaries of administrative unit.*
 - (iv) *Facilities of communication*
 - (v) *And cognate of factors to ensure Homogently in the creation of constituency.*
12. *That new created district has the object to benefit and accommodate people of the area and also to provide guarantee of life and security, but due to serious dispute between Zehri and Lehri tribe there is serious apprehension*

- 13. Inclusion of Dasht-e-Goran in new created district is un-natural and against the will and wish of the people of the area. Even otherwise against Notification dated 08.09.2017 a Constitution Petition No. 1298 of 2017 is also pending before Honourable Balochistan High Court Quetta.
- 14. That notables, respectable, elders of the area neither intimated nor taken in to confidence before inclusion of Dasht-e-Goran in new district Shaheed Sikandarabad.

PRAYER



To pass any other appropriate order as is deemed fit and proper in the circumstances of the case in the interest of justice.


