Objections

That as the census in the year 2017 have conducted in the month of June & July and the Harnai District is one of the Warm areas of the Country and at the time of the census more than 30% peoples have been migrated to the cold area due to which fair census had not been conducted and on this ground the constituencies cannot be delimit and are liable to be reversed.

That the Harnai District is geographically is mountainous region and the majority of the population is inhabited on the top of the par plunge hills where the census terms did not approached at all therefore. Constituencies are not been just to delimited in such conditions.

That it is the admitted fact that there are the existence of banned organizations in the District Harnai specially Shahrug who spread fair and harassment in the masses to remain far from the census work, if the masses participated in the census be responsible of dire consequences, on this ground alone the delimitation of constituencies are to be set aside.

That several matter has been reported that the teachers refused to go the several areas of the district due to sever threats, on this ground the census is not correctly conducted previously positions.

That, irrespective of above that in the census year of 1998 when the majority of the population of the area specially the worker of PKMAP boycotted and then the population of the District Harnai were recorded as 75500, but surprisingly after the laps of almost 20 year the present census recorded the population as 97017, on sole ground the delimitations are not teen able and are liable to be rejected.

That even otherwise according to the universal principles of the world the population has to be increased about 3% but the same formula as well not applied in the District Harnai.

That, the district record of polio vaccinations they have recorded the 23890 has been vaccine, which a fact as well negate the fairness of census 2017, and doesn't provide base for the limitation of the constituencies.

That according to the record of primary education of the District the 15000 students are getting education only in primary level this fact as well negate the census of 2017, and does not provide basis for limitation of constituencies.

That the newly constituencies are limited into unnatural geographical areas due to which the public at large would face hardship and even they cannot approach the areas as such the delimitation is unnatural and is liable to revised.

That, irrespective of above, several constituencies have been delimited on the population less than 241000 and the constituency P.B. 22 and N.A. 265 has discriminated, on this sole objection the present limitation of constituencies are not tenable and are liable to be revised.

Majority of the population reside around the census now revealed areas and there are no proper census block, due to the movement of the people of the same area they were travel and transported their animals to other areas/regions for which the census was not properly conducted.

For the above reasons the status of the District Harnai was totally destroyed, it want to be restored and reversed as old position as per year 2002.
