REPRESENTATION IN RESPECT OF OBJECTION
PETITION TO THE DRAFT D-LIMITATION OF
DETACHED FROM PK-12 DIR-III TO PK -10 DIR-I

Respectfully Sheweth;

1. That the petitioners are permanent resident of UC-Swani situated in Tehsil and district Dir. At the very initial stage this constituency was known as PK-91, however, upon after census D-limitations have been made by detailing UC-Swani from PK-12 Dir-III including PK-10, Dir-I which require rectification/ with drawl/ amendment for the following reasons.
2. That people of UC-Swani and residence of PK-10 are culturally language wise are different and they are Kohistani Speaking people where as the language of the UC-Swani is Pashto and are also spoken in PK-12.
3. That Dir has a Tehsil Known as Sherigal which is far away from UC-Swani more than 50 Kilometers.
4. That Patwar/ Revenue Circles in PK-12, Dir-III are much nearer to the UC-Swani , thus it will be highly in-conceivable to the resident of the UCswani

to approach the Tehsil at Sheringal .

5. That previously as per 6 population and housing census 2017 the UC-Swani was a part of Dir sub Division and detaching it from PK-10 Dir-I will be upsetting in Natural boundary which is observed and already accepted by people of the area since many decades.
6. That residents of the area has time and again raised many objections in this regard and district election commission Dir Upper has also recommended that necessary correction be made in public interest vide letter dated 26 march 2018. (Copy Enclosed).
7. That by the proposed D-limitation UC-Swani has been submitted to PK-10 by splitting villages consist into two sub division disturbing enlisting local Government system in the area.
8. That resident of the UC-Swani feels that their UC will be having portion in minority due to cultural language, education and many social factors will create in since of depression and complexity as they will not be in a position to approach their public representative .
9. Since the basic facilities hospital, Govt: offices shall be in an area 50 kilometers.
10. That PK-12 Dir-iii consist of agriculture area where as PK-10 has a barren and mountainous area with a different backgrounds of their origin

and many bloodshed enmities are going with the people living adjacent to afore stated VC's thus by adding these Swaini Shall leave the people/residents at the hands of their rivals who will be in majority.
