مودبانہ گزارش ہے کہ ضلع ایبٹ آباد کے حلقہ نمبر، 36، 37، 38، 39 میں کی جانے والی حلقہ بندیوں کے خلاف قلندر خان لودھی نے آپ کے پاس اعتراضات جمع کرائے ہیں جن میں ذکر کیا گیا ہے کہ حلقہ، 36، 37، 38، 39 کے لوگوں کی زبان اور دوسری چیزیں ایک دوسرے سے مختلف ہیں جن کو مد نظر رکھتے ہوئے ان حلقہ بندیوں کو تبدیل کیا جائے، جس میں پٹوار سرکل حویلیاں دیہہ کو حلقہ 38-PK سے نکال کر 37-PK میں شامل کرنے کیلئے اعتراضات جمع کروایا گیا ہے۔ (ڈاکومنٹس ساتھ لف ہیں)

جبکہ یہ اعتراضات حقیقت کی بنیاد پر نہیں ہیں بلکہ یہ صرف سیاسی اور ذاتی مفاد کی خاطر اعتراضات پیش کیے گئے ہیں، اور ان علاقوں میں ہندو کے علاوہ کوئی اور زبان نہیں بولی جاتی۔

الیکشن کمیشن کی طرف سے کی جانے والی حلقہ بندیاں آئین اور قانون کے مطابق بالکل درست ہیں۔ اور پٹوار سرکل حویلیاں کی عوام ان سے مطمئن اور خوش ہے۔

PRAYER: ON ACCEPTANCE OF INSTANT  
MEMORANDUM / REPRESENTATION DRAFT  
PROPOSAL IN RESPECT OF PK-36, PK-37, PK-38 & PK-39  
ABBOTTABAD MAY KINDLY BE MODIFIED / SET-  
ASIDE AND CONSTITUENCY PK-36, PK-37, PK-38 & PK-  
39 MAY KINDLY BE NOTIFIED AS PER PROPOSAL BY  
THE PETITIONERS ACCORDING TO LAW.

Respectfully Sheweth:-

Facts giving rise to the titled petition are as under;-

1. That petitioners No. 1 to 13 are residents  
and voters in Patwar Circle Bandi

Dhoondan, Abbottabad, petitioners No. 14 to 23 are residents and voters in Patwar Circle Tamawai, proposed PK-36, Abbottabad and petitioners No. 24 to 33 are residents and voters in Patwar Circle Banda Pir Khan, Abbottabad proposed PK-39 Abbottabad. Copies of CNICs and list having registered vote number duly signed by the petitioners are annexed herewith.

2. That previously before delimitation of the constituency Abbottabad-I, II, III & Abbottabad-IV were PK-44, PK-45, PK-46, PK-47 & PK-48. Map showing the previous constituency is attached herewith.
3. That according to recent report total population of Abbottabad District is 13,23912 previous PK-44, PK-45, PK-46, PK-47 & PK-48 constituencies which were having Geographically, compact areas, physical features, existing boundaries of administrative units, facilities of communication and public convenience and other cognate factors were well according to rules and were in the public interest.

That peoples of the locality were also having no objection whatsoever, and there was no need to disturb the previous delimitation, only variation in the population of the constituency can be met by slight modification by joining two Patwar Circles i.e Bandi Dhoondan and Tarnawai from proposed constituency PK-36 to proposed PK-38 and one Patwar Circle Banda Pir Khan from proposed PK-39 to proposed PK-38. Copies of site plan showing preliminary report and list of constituencies specifying the area included in each constituency is annexed herewith.

That proposed delimitation of the constituencies of PK-36, PK-37, PK-38 & PK-39 Abbottabad may kindly be modified inter-alia on the following grounds:-

GROUND:-

- a) That preliminary report of constituencies PK-36, PK-37, PK-38

& PK-39 Abbottabad is not according to rules and law laid down by the apex court of the countries from time to time.

- b) That preliminary report is not based on facts on grounds.
- c) That previous constituency is based on geographically compact block physical features and there are communication facilities in between the areas, and there is also public convenience cognate factors and homogeneity in the constituencies which is lacking in the preliminary report of newly proposed constituencies.
- d) That proposed constituency PK-36 is totally based on rural area having less education facilities, no road excess, no communications and also traditionally difference of caste, homogenous, culture and language

from the peoples/ inhabitants of Patwar Circles Bandi Dhoondan & Tarnawai. Similarly Patwar Circle Banda Pir Khan is situated nearby the Patwar Circle Bandi Dhoondan & Patwar Circle Tarnawai and there is also no road excess to the peoples of

Patwar Circle Banda Pir Khan to PK-

39. It is pertinent to mention here that the Patwar Circle Bandi Dhoondan Patwar Circle Band Pir Khan and Patwar Circle Tarnawai are situated in Union Council Banda Pir Khan.

- e) That if the proposed constituency is approved, in that case the inhabitants Patwar Circle Bandi Dhoondan & Tarnawai of proposed PK-36 will proceed to constituency they will travel approximately more than 100 Kilometers, firstly travel to District Mansehra, secondly Muzaffarabad AJK and then via Kohala they reached in Bakot of the proposed constituency, similarly Lora has also

been included in the said proposed constituency which is situated at boundary line of District Abbottabad adjacent to Murree, Islamabad and District Haripur and also a far-flung area of the inhabitants of the Patwar Circle Bandi Dhoondan and Tarnawai.

**SUGGESTIONS:**

**i) Patwar Circle Bandi Dhoondan & Patwar Circle Tarnawai.**

The residents / voters of Patwar Circles Bandi Dhoondan and Tarnawai has already been connected through road with Ex. Constituency PK-46 now proposed PK-38 (Tanawal) and they are availing all the routine facilities from the said constituency and also their caste, homogenous, culture and language are same. ?

Patwar Circle Bandi Dhoondan & Tarnawai are already connected with different track of roads with PK-38 and also within the

District, due to said reason it is very comfortable for the females and accessible.

Residents/ voters of Patwar Circles Bandi Dhoondan Tarnawai are convenience with attachment of newly preliminary proposed PK-38.

The residents / voters of Patwar Circle Bandi Dhoondan & Tarnawai are attached with (Ex. Constituency of PK-46) now PK-38 for the last three tenure, therefore attachment of these Patwar Circles with PK-38 will effect vote turn out positively.

After exclusion of the above two Patwar Circles from PK-36, three Patwar Circles i.e Majohan, Dana Noraal and Langrial which are adjacent to PK-36, may be reallocated from PK-37 and further attached/absorbed with PK-36 to cover the required population target and variation in between the other constituencies.

After exclusion of three Patwar Circles Majohan, Dana Noraal and Langrial from

PK-37, one Patwar Circle i.e Havelian Dah which are adjacent to PK-37 having same tradition, culture, language and easy road excess etc. may be reallocated from PK-38 and further attached/ absorbed with PK-37 to cover the required target of population and variation in between the other constituencies.

ii. **Patwar Circle Banda Pir Khan**

Due to inclusion of residents / voters of Patwar Circle Banda Pir Khan in PK-38, the difference of variation of population of PK-39 with other constituencies will be removed. Exclusion of Patwar Circle Banda Pir Khan from PK-39 will not effect the population.

Residents / voters of Patwar Circle Banda Pir Khan is connected with PK-38 through Shahrah-e-Resham and also availing the routine facilities.


