UNDER SECTION 21(3) ELECTIONS ACT 2017 READ WITH RULE 12 OF ELECTION RULES 2017 REGARDING ALTERATION OR MODIFICATION IN THE PRELIMINARY LIST OF CONSTITUENCY PK-6 SWAT-VII.

Respectfully Sheweth:-

The Petitioners; namely Amjad Ali etc. are residents of Tehsil Babuzai and voters of Provincial Constituency PK-4 Swat-III. The Vote Certificates of the petitioners are attached herewith.

The petitioners have the following reservations on the draft list of Constituencies PK-4 and PK-6as notified along with map by the learned Election Commission of Pakistan:-

- That Patwar Circles of Marghuzar, ISalampur, Guligram and Qambar are part of Tehsil Babuzai. This area is lying on the boundary of Bunair. In the recent delimitation process, some of its area has been including in PK-4 whereas sufficient area is still in PK-6. Through this division the people of the above area have been badly discriminated as the population of this area is very small. On the other hand the areas of PK-4, which is not linked with this area, as shown in the ECP map as a neighbourhood is consist of a very large number of populations. The population of PK-4 is large and the people of this area do not expect fair treatment with them in the developmental process. Secondly, this area is not at all directly connected with PK-4 in any manner rather the people of this area would cover a long distance of about 20 to 25 km in the congested area of Mingora City (PK-5) to reach the area of PK-4. This area is a pocket one for PK-4 which is a clear violation of the delimitation Rules, 2017, which is shown in the C&W map road, attached with this representation.
- Now according to the ECP map, Patwar Circle of Balogram has been broken and shown in PK-6 and its two number of MauzaJaat have been shown in PK-4, which is a clear violation of the Delimitation Rules, 2017 and similarly, PC of Odigram is divided into two portions i.e. one Mauza has been included in PK-6 and other Mauza has been included in Pk-4, as shown on the map issued by the ECP.

According to our proposal, if the Patwar Circles of Islampur, Sherataraf, Marghuzar and Qambar is detached from PK-4 and included in PK-6, which is easily approachable to Tehsil Barikot. The whole area is lying on one and the same Road and also on one side of the river. In the previous election these Patwar Circles were part of one Constituency in PK-81 which is now PK-6. By accepting this proposal, the administrative Unit of Barikot Tehsil would remain intact is which proved by the Road Map, which is attached. The area of Tehsil Barikot and Tehsil Babuzai is lying main GT Road of Swat and their geographical, traditional and other communicational links are one and the same.

It is, therefore, humbly requested that the above stated reservation may so graciously be considered in the light of the proposed map, map of C&W Highway, contiguity, communication facilities and other factors already stated. Further, favourable/supportable relevant documents in our presentation will be presented at the time of hearing.
