OBJECTION ON DELIMITATIONS OF PK 6 SWAT -5

Respected Sir,

1. That the petitioner is permanently resident of Balogram Tehsil Babuzai District Swat since his forefathers and the petitioner is also related to the Halqa PK-6 Swat-5, bearing Block Code No.007011025 Vote Serial No.697.
2. That the Election Commission prepared the Provincial constituencies and its delimitations which are not according to the natural boundaries of the constituency with relates of its villages, population, and patwar circles.
3. That in this regard the petitioner has extreme grievances, therefore, the petitioner submits the instant petition on the following grounds:
 - i. That the said constituency is situated on both the banks of swat River. Three of the union councils of this constituency have been included in PK-6 Swat -5 situation of which is unnatural and objectionable, wherein the Patwar Halqas Garhi, Dadhara, Kotli, Dagi and Akhund Kalay of UC Koz Abakhel Tehsil Kabal have been included by way of unnatural act, which creates numerous problems for the public of these areas during Election.

- ii). That while making the delimitation of the above constituency Halqa Patwar Circle was not considered its necessity. For Example Mouza Qamber (2) Mouza Batorha (3) Mouza Gulli Gram which exists in Electoral Map of Mouza Qambar. One of these mouzas , Mouza Qambar wrongly included in Pk-4 Swat -3 which is quite unnatural.
- iii). That in this regard the petitioner has proposed appropriate proposals which are feasible to facilitate the voters of the areas and the population of the areas has also been considered /kept in view by the petitioner.
