Respected Sir,

(1) That the petitioner is the law abiding citizen of Pakistan resident of village Pawaika. Peshawar

Therein and also mandate, under article 51(5) of the constitution of Islamic Republic of Pakistan 1973 the Election Commission of Pakistan (herein after referred to as 'the commission') started to conduct delimitation of constituencies of National and Provincial assemblies in accordance with provision of newly enacted election act 2017 (herein after referred to as 'the act') and the election rules 2017 (herein after referred to as 'the rules') made thereunder:

(3) That the commission v/s of the act, vide its notification (impugned notification) in official gazette dated 05.03.2018, inter-alia, proposed the delimitation of constituencies of Dish Peshawar whereby 5 National Assembly constituencies ranging from NA 27 to NA 31

and 14 provincial Assemblies ranging from PK 66 to PK 79 have been created.

(4) The proposed delimitation, though was made in good faith and for ease and accessibility of populous however, the same being ultra vires the act and the rules will instead be a cause of tremendous inconvenience, for the candidate, contesting from, and the voters, of the proposed constituencies.

5) That being aggrieved of proposed delimitation by the Commission, vide the impugned notification, the representative seek to amend, alter modify and propose, details of how the constituencies PK 72 and 74 in Jesh Peshawar, be delimited, inter-alia on the following ground.

Grounds

Mr. (04)

① It is pertinent to mention to give any regard to the physical features, facilities of communication and public convenience and boundaries of administrative units to insure homogeneity.

② The proposed delimitation of P.C. Dawak which consist of charge 16 Block 9 is put in P.K. 74. which unjustified on the following ground.

as shown in ECP maps, Pakistan
Railway line cuts charge
16 Block 9 from the rest of
PK-74.

3. Main 60 metre G.T. Road
which is main artery road
of Peshawar also cuts charge
no 16 Block 9 from the rest of
PK-74.

6/ As you may know that
pro-Govt is building Bus Rapid
Transport system. This Transport
system have it dedicated
U-turn and interchanges to
cross, 95% of PK-74 is at
the other side of massive Bus
system, while charge 16 Block 9
population is cut off from PK-

⑤ As can be seen in
ECP map change 16 Block 9,
Population 23,357. is more
homogeneous and connected with
PK. 72. It also share same
in N.A 29 constituency with
PK 72. PK. 74 is in NA 30.

6) So it is requested that
change 16 Block 9 population
23,357 be merge with PK 72
