SUBJECT: PETITION/REPRESENTATION UNDER SECTION 21 ELECTION ACT, 2017, READ WITH RULE 11 OF ELECTION RULES 2017, FOR MAKING APPROPRIATE CHANGES IN THE PROVINCIAL CONSTITUENCIES OF DISTRICT BANNU i.e. PK-87 & PK-88.

Respectfully Sheweth;

That, the petitioner is bona fide resident of village Maley Khan Kala Tehsil Domel District Bannu and is voter in PK-87. The petitioner is social worker and is patriot.

2) That, the District Bannu was comprising of four provincial halqajat i.e. PK-70, 71, 72 and 73. And now in the new delimitation this Honourable Commission change the above constituency into 87 to 90.

(Copy of proposed notification issued by this Honourable Commission hereby annexed as Annexure-B)

- 3) That, the total population of PK-87 is 297697 and total population of PK-88 is 289647.
- That, the Ward No. 5/Union Council Shamshi Khel previously was in PK-71 now PK-87 and in the new delimitation Ward No. 5/Union Council divided into two parts and brought one part i.e. Kotpasha PC into P.K-88 from PK-87.
- 5) That, the total difference of population between PK- 87 and 88 is 8050 i.e. the population of PK-87 is higher than PK-88.
- That, the total population of Ward No. 41/Union Council Shabaz Azmat Khel is 19737 which is situated in PK-87, and if this union council is included in PK-88 and Kotpasha PC included in PK-87 then the population of PK-87 will be 293176 and the population of PK-88 will be 294168. Meaning thereby that there will be only 992 voter's difference between the two constituencies.

7) That, the petitioner being aggrieved having no other adequate remedy in hand comes to this Honourable Commission, inter alia on the following grounds.

GROUNDS:

a) That, the new delimitation is against the fundamental rights of the petitioner as well as of the whole constituency and locality being unconstitutional, illegal, void and annihilation upon the rights of the petitioner and population of both the constituencies.

b) That, due to delimitation the Ward No. 5/Union Council Shamshi Khel is fully affected and divided into two parts one is given to PK-87 and the other to PK-88, although, the Ward No. 5/Union Council Shamshi Khel is geographically situated in PK-87. And Ward No. 5 Shamshi Khel having their own traditions and having Ghami and Shadi with each other and due to new delimitation one brother will caste vote in PK-87 and the other will caste vote in PK-88.

c) That, the people of Kotpasha having no relation whatsoever with people of PK-88.

d) That, if the Ward No. 41/Union Council Shabaz Azmat Khel bring to PK-88 and in lieu of the said Kotpasha PC bring into PK-87 then the population will not be affected nor would the geographical location of both the constituencies be effected.

For the above stated reasons and other to be stated at the time of arguments, it is, therefore, most humbly prayed that on acceptance of this petition, this Honourable Commission may very kindly be make an appropriate order with the directions to the respondents to make changes in the PK-87 and 88, and bring Kotpasha PC from PK-88 to PK-87 and in lieu of the same Ward No. 5/Union Council Shahbaz Azmat Khel be bring from PK-87 to PK-88, being geographically and population wise will be fit and will be for the betterment of the people of both the constituencies.

Any other relief, if this Honourable Commission may deem fit in the circumstances may also be granted.
