Respectfully Sheweth!

1. That, the petitioner is a registered votes of PK-38 Abbottabad 3 and formerly PK-47 Abbottabad 4 and is aggrieved due to inclusion of Patwar circles of Orash, Qanungo Halqa of Tehsil Abbottabad namely Baldheri, Banda Qazi and Jhangi by including the same from PK-36 formerly PK-47.

2. That, the petitioners are permanent residents of Tehsil Havelian and are residing there from forefathers and are also hails from the political and social families of Tehsil Havelian.

- That, District Abbottabad firstly consists 3. of Tehsil Abbottabad and Tehsil Havelian and nowadays two new Tehsils i.e. Tehsil Lora and Tehsil lower Tanawal Lora has been established and four administrative national units separated by a geographical boundary of (mountains range and river and plane) all these connected administrative units are through roads and others sources and also connected through KKH and that prior to the proposed delimitation both the old Tehsils and their respective administrative boundaries are the limits of their respective constituencies i.e. PK-46, 47 and 48.
- That, before the proposed delimitation, 4. seats of Provincial are five there Assembly which were PK-44 to 48 but due to new census one seat of the Provincial Assembly has been abolished in Abbottabad District and now there are 04 seats which have given new names PK-36 PK-39 and according to proposed delimitation Mouza/Patwar circle of Qanungo Halqa of Tanawal Orash and Mouza Havelian Tehsil were joined together and new Halqa PK-38 has been established, which is against the


wills of the people of the Patwar Circle/Qanungo Halqa (1) Garhi Phulgran (2) Rajoya (3) Bandi Attai Khan (4) Langra-I (5) Langra-II (6) Phullan Wali and a clear discrimination heavy loss to the peoples of above mentioned Mouzas.

5. That, the total population in District Abbottabad according to the census of 2017 is 13,32,912 in numbers and which has been divided into two seats of National Assembly and four seats of Provincial Assembly.

That, exclusion of Patwar Circle Garhi 6. Phulgran, Rajoyia, Bandi Attai Khan, Phullan Wali, Langra-I, Langra-II from PK-38 and inclusion of Patwar Circle Baldheri, Banda Qazi and Jhangi in PKthe proposed delimitation is 38 in without any geographical and cultural Tehsil Havelian compactness e.g. including Havelian city has been divided into two parts, and one part of Havelian is included in PK-37 and rest of the area has been included in PK-38 which are not easily accessible. Similarly, divisions




of main city of Havelian into two constituencies is not warranted under the law and facts also as all population of Havelian city alongwith surrounding areas can easily be adjusted in PK-38 and Baldheri, Banda Qazi and Jhangi Patwar Halqa can easily be adjusted in PK-36 and this makes a well reasoned geographical units. All the above factors are not only inconvenient candidates the intended to particularly public at large as more than 70,000 population is effected from the proposed delimitation.

- 7. That, in the proposed delimitation, PK-1 Chitral and PK-35 Torghar has been ignored due to their geographical location, administrative and communication problem.
- 8. That, this Honourable Commission can appoint local commission for physical inspection of the proposed delimitation of constituencies particularly area of Patwar Circle Garhi Phulgran, Rajoyia, Bandi Attai Khan, Phullan Wali, Langra-I and Langra-II.

That, the above-mentioned six Patwar 9. Circles have population amounting to 70,000 and Havelian which is a Tehsil of District Abbottabad have a propriety rights to be included in PK-38 as the population of above-mentioned six Mouza Jats/Patwar Circles have their similar geographical and cultural compactness and are easily accessible through land and are also adjacent to each other Banda Qazi Baldheri, whereas Jhangi can easily be excluded from PK-38 and can easily be included in PK-36 and similarly, Lora Tehsil can easily be excluded from PK-36 and can easily be included in PK-37 so that population of above-mentioned area and Patwar Circles can easily cast their votes on nearest polling station and can cast their vote elect their representatives and can according to their whims and wishes.


