## REPRESENTATION/OBJECTION ON DELIMITATION OF PROVINCIAL ASSEMBLY PP-7 (EX PP-2) DISTRICT RAWALPINDI.

Respectfully Sheweth:-

- 1. That the petitioner/objector is Chairman of Union Council Manyanda No.25 and voter member of Village Banahal.
- 2. That above said Union Council is part of Choha Khalsa Kanoongoi Tehsil Kallar Syedan District Rawalpindi.
- 3. That this Union Council was part of NA-50, PP-2 Rawalpindi previously. The Provincial Assembly included Tehsil Kahuta and Kanoongoi Choha Khalsa of Tehsil Kallar Syedan District Rawalpindi.
- 4. That now Kanoongoi Choha Khalsa except patwar circle Nala Musalmana and Mamyal have been included in PP-8 alongwith 5 Kanoongoies of Gujar Khan Tehsil.
- 5. That the petitioner is elected representative of Union Council Manyanda and after delimitation of constituencies convened meeting of Union Council and the house unanimously passed resolution for inclusion of Kanoongoi Choha Khalsa in PP-7 and disapproved inclusion of Kanoongoi Choha Khalsa in Tehsil Gujjar Khan.

6. That the petitioner assails the inclusion of Kanoongoi PP-8 on the following amongst other:-

## **GROUNDS**

- a. That our PC Banahal has only one road link with rest of Kanoongoi that passes from PC Nalla Musalmana which is included in PP-7 with Tehsil Kahuta.
- b. That our Patwar Circle and most part of our Kanoongoi is comprised of hilly area and same is the case with Tehsil Kahuta, so the area is homogeneous in kind.
- c. That both Tehsil Kahuta and our Kanoongoi are part of same National Assembly and it will create great hardship for presiding officer to produce election result and record etc before two different returning officers sitting in two different cities. This will raise question upon the fairness, justness and impartiality of election because it will create delay in pronouncement of election results.
- d. That our Kanoongoi has been divided in two parts which will reduce the chance of its inhabitants to get elected. It is also worth mentioning here that our Kanoongoi Choha Khalsa remained together previously in all delimitations.









- e. That our Kanoongoi was part of PP-2 with Tehsil Kahuta since 2002 and people were satisfied and happy in this constituency.
- f. That this constituency PP-7 (Kahuta + Choha Khalsa Kanoongoi proposed) forms more compact constituency geographically.
- g. That the people of Kanoongoi Choha Khalsa remained in one National Assembly constituency since 1970, so the people are having relationship, contacts and interdependence amongst themselves.
- h. That now other part of Tehsil Kallar Syedan i.e Kanoongoi Kallar Syedan has been included in the previous PP-2 and now PP-7. This Kanoongoi Kallar Syedan was part of PP-5 now PP-10.
- That in present delimitation Kanoongoi Sukho of Tehsil Gujjar Khan has been included in previous PP-5 now PP-10 which was part of PP-4 Gujjar Khan.
- j. That in case PP-4 is restored and Sukho Kanoongoi is included in PP-9, it will form one constituency of National Assembly and Provincial Assembly in one Tehsil and also one returning officer.
- k. That it will be more appropriate, convenient and lawful if Choha Khalsa Kanoongoi, Kallar Syedan

Kanoongoi and Sukho Kanoongoi is restored in there previous provincial constituencies.

- 1. That this restoration will not affect population criteria at all.
- m.That the present delimitation of Provincial Assembly in Rawalpindi is against Section 20 Principals of Delimitation because the constituencies are not geographically compact and physical features, existing boundaries of administrating units, facilities of communication and public convenience have also been ignored.
- n. That the proposal of the Provincial constituencies of district Rawalpindi is annexed as Annexure "A".

It is, therefore, respectfully prayed that instant petition of representation/objection may very graciously be accepted, Choha Khalsa Kanoongoi, Kallar Syedan Kanoongoi and Sukho Kanoongoi may kindly be restored in there previous constituencies as indicated in Annexure "A".
