- 1. That the applicant is the permanently resident and chairman of UC-110 Lodhra Tehsil and District Rawalpindi presently satiated in provincial constituency of Punjab PP 10, by new delimitation policy of the election commission of Pakistan.

- 6. That being a representative of local people of the constituency I am duty bound to protect the rights of the peoples of my constituency.
- 7. That the areas mentioned supra both Qanoon goi(s) i.e Qanoon Goi Ghorakh por and Bandda may kindly be placed in the PP-10 and Qanoon Goi Sehal and chakri may kindly be placed in PP14 keeping in view the geographical location of both the map regarding the new proposal is attached herewith for the kind perusal of the authority /commission.
- 8. That by switching the Qanoon Goi(s) the population remains almost the same as proposed by the applicant.
- 9. That if the present petition is allowed there will be no disturbance in the local residents or their approach to the govt. and the political representatives.

10. That Qanoon Goi(s) Ghorakh por and Bandda may kindly be placed in the PP-10 and Qanoon Goi Sehal and chakri may kindly be placed in PP14 for the convenience of the local inhabitants of the area.

In the light of the above mentioned circumstances It is therefore most respectfully prayed that the instant objection petition may kindly be allowed and adjust the qanoon goi(s) Ghorakh por and Bandda may kindly be placed in the PP-10 and Qanoon Goi Sehal and chakri may kindly be placed in PP14 for the convenience of the local inhabitants of the area in the best interest of Justice as the liberty is the fundamental right of every person as well as the right to vote and expression is also a right of every citizen under the constitution.
